Thank you for your letter of January 1975, concerning the announcement that the publication of Radiation Data and Reports (RD&R) would be discontinued. While our decision to terminate its publication included limited resource considerations, our fundamental rationale was to provide the data published in RD&R in a more useful form. To implement this rationale, ORP will issue two annual reports, "Assessment of Radiation Protection in the U.S.," and a "State of the Environment Report."

The first report will contain a summarization and analysis of the significant events of the previous year, the impact of these events on current and future radiation protection policies and programs, and a forecast of the directions of radiation protection throughout the world. It will serve as an overview of all radiation activities aimed at the general reader.

The second report will be a presentation of environmental data, including the data previously published in RD&R, in a form emphasizing observable trends as opposed to tabulations of raw data. The benefits of the data in this form would be that a user would be able to determine the rate of improvement or degradation in the environment and population, the impact of radiation exposure on health effects, statistical descriptors for particular areas of radiation exposure, and the impact of additional radioactivity in specific source areas.

To the extent possible, the annual reports will include information and data from other agencies, public groups, and international activities. We plan to publish the first "Assessment of Radiation Protection in the U.S." in the fourth quarter of FY-75 and the first issue of the "State of the Environment" in the first quarter of FY-76. In 1976, and subsequent years, these reports will be issued in January and July, respectively.

In addition to the two annual reports, we will publish technical reports as they are prepared rather than in a monthly publication. As a result, we expect the information in the reports to be more timely and useful; i.e., the lead time from completing the report to publishing it will be reduced, and the distribution of the report will be primarily to organizations and individuals having an interest in the subject matter.

Finally, the raw data previously published in RD&R are available to the public on a cost reimbursable basis. These data can be obtained by requesting them from the Eastern Environmental Radiation Facility, U.S. Environmental Protection Agency, P.O. Box 3009, Montgomery, Alabama 36109. A fee schedule will be enclosed with each set of data transmitted. Institutional contributors to the data file will be provided the data they request at no cost.

These improvements will assure the continued availability of environmental radiation data to the public. I appreciate your support of RD&R and hope that you find the new services of ORP of more benefit to you and your colleagues.

This is in response to your letter expressing concern over recent budget decisions relating to EPA's Air Pollution Training Institute (APTI) and the funding of State and local pollution control agencies.

The Public Interest Campaign has interpreted the 30 position reduction in the APTI as an elimination of this program. In fact, funding for APTI will be the same in FY 1976 as it is in FY 1975. The 30 position reduction represents a freeing of financial resources for the purpose of increasing the use of private contractors. This action will strengthen the program by enabling the APTI to meet the individual needs of State and local trainees more fully and expeditiously.

The planned obligational level of air and water control agency grants will be the same in FY 1976 as it is in FY 1975. However, the original intent of Federal funding was to establish and develop sound environmental programs at the State and local levels, but not to maintain their operation indefinitely. The continued operation of this program, therefore, is believed to be the role of those levels of government. Since all States and many localities now have well established pollution control agencies, the Federal Government could begin phasing out these grants.

In addition, concern has been expressed over the degree to which State and local control agencies are becoming more responsive to the desires of the Federal Government rather than the State or local governments of which they are a part. To the extent that this occurs, it is felt that control agencies are by-passing the checks and balances which are imposed by the normal political process through elected officials. Instead, these agencies have a potential for becoming Federal Government enclaves at the State and local levels.

Lastly, it is felt that some of the financial support for control agencies can be self-generating through the institution of user charges, such as permit fees. amount of support possible, under this funding mechanism is not known, but user charges are, generally, a progressive taxation mechanism and therefore would be equitable in their implementation.

Dear Congressman Broomfield:

This is in response to your letter of February 3, 1975 on behalf of J. T. Cunningham who is concerned that the Selective Service System has an annual budget of \$50 million, even though there is no longer a draft.

The Administration is committed to maintaining our nation's standby draft posture in a state of readiness sufficient for mobilization purposes. Adequate peacetime funding permits early delivery of draftees to meet anticipated manpower shortfalls that would appear in a major armed conflict.

In an effort to sustain that required capability at minimum costs, the Selective Service System will begin major program adjustments in 1976. Local board operations will be phased down while a new standby system is tested. An annual registration system will be evaluated. Alternate induction procedures will be developed for possible use in a major contingency, and classification activity will be deferred until such time as induction authority may be requested by the President. These adjustments are designed to permit significant operating cost savings beginning in FY 1977.

Mr. Cunningham's interest in this matter is appreciated.
