Murphy Gets Korea's Than

Rep. John M. Murphy (D-NY) arrived in Seoul, Korea, the morning of Feb. 15 to participate in an official ceremony commemorating the 5,000th day of the 2nd U.S. Infantry Division serving in Korea. In extending the invitation to the New York Congressman, the Chairman of the U.N. Korean War Allies Association, Lt. General Il-Hwan Kim (ret.), described Murphy as "the first U.S./Korean War Hero to be honored with this award in appreciation of his continued contributions to maintaining the survival of the Republic of Korea."

Murphy is one of the most decorated officers of the Korean War where he served with the 9th Infantry Regiment of the 2nd Division. The 2nd Division was credited with saving the U.N. force and turning the tide of the war in Korea in one of the bloodiest battles of the conflict which occurred on September 5th and 6th, 1950, at the Naktong River.

As a result of that action the 2nd Division broke out of the Pusan Perimeter and drove north to link up with the U.S. 7th Infantry Division which had landed at Inchon. This link broke the back of the 300,000 man Commu-

nist North Korean Army.

For his contribution to that battle, in an action 22 miles north of the tip of the Korean peninsula, Lieutenant Murphy received the Distinguished Service Cross when his platoon mauled a large North Korean infantry unit and forced it into retreat. An enemy shell then burst over Murphy's head and he "went down in a shower of iron fragments," receiving multiple wounds for which he was given the Purple Heart, Murphy subse-

quently received many other U.S. and foreign citations and decorations including the Bronze Star with V and Oak Leaf Cluster, the Korean Service Medal with six battle stars, and the Chungmu Distinguished Service Medal from the Republic of Korea.

In brief remarks Murphy told the assembled military and civilian dignitaries, "When I accepted the invitation to attend the ceremony commemorating the '5000th Day' in Korea of the United States Army's Second Infantry Division. I became curious as to how many other Members of Congress had served here during the Korean War. My research surfaced the names of some thirty of my colleagues on The Hill who saw service in Korea during that conflict. Included were five Senators and twenty-five Representatives.

"And the cross-section seems to be truly 'representative.'

"All branches of the service were represented-Army, Navy Air Force and Marines. The Korean veterans on Capitol Hill include such 'oldas Congressman Sam Steiger, Congressman Sam Stratton and Senator Hugh Scott. But also, some of the 'freshmen' served there. For example, the new Congresswoman Helen Meyner from New Jer' sey was a volunteer with the American Red Cross in Korea for eighteen months in 1950 through 1972. Thus, we have both men and women in Congress who have some first hand experiences and understanding of this great country and the still continuing struggle it is having with the Communist North Koreans.

That this tragic struggle continues, and has defied solution, is frequently, and sometimes dramatically, brought to our attention.

"Thus, against this pessimistic background, it has been the consistent policy of the United States to continue to support the people of the Republic of Korea in their struggle toward independence and security from the aggressor to the North.

"During those dark days in the fall of 1950, 'Free Korea' consisted of little more than the Pusan Perimeter-a beleaguered plot of ground about fifty miles on each side. The American and Republic of Korea Armies, their backs to the sea, were under severe attack by the North Korean Army. The U.S. forces, the South Korean government, its military forces and its economy were in disarray. But we turned a much predicted rout into a glorious victory. We were not 'pushed into the sea' as the world expected. And since that time, with the aid of her allies, the Republic of Korea has grown into one of the strongest nations in Asia, both militarily and economically.

"The Republic of Korea Army is supreme-second to none in the

world.*
While in Korea, Mr. Murphy met with Korean President Park and other high ranking members of the government. Secretary of the Army Howard H. Callaway has asked Murphy to report to him on "the state of the Army in Korea" upon his return.
