#### II. BACKGROUND, PARTICIPANTS AND PRESS PLAN

#### Background: A.

- 1. The late Corporal Silva was born in Mexico in 1946 and admitted to the United States for permanent residence in April 1956. His mother and several of his 15 brothers and sisters have become citizens and his application was pending when he was killed in Vietnam in December of 1965. He postponed becoming a missionary in order to enlist in the Army and he received six decorations and awards, including the Purple Heart.
- 2. The bill was suggested to Rep. Brown by the San Bernardino Junior Chamber of Commerce, the editors of the local newspaper and other civic leaders.



He introduced it and herded it through Congress.
Rep. Brown asked to be present when the bill
was signed and he also asked to be allowed to
invite several others, including Silva's parents.
In order to minimize the risk of being accused
by Republicans in his District of giving a boost to
Brown politically, we turned down his request for
other participants in the thought that we should not
raise the visibility of the event more than necessary.
The brief time available for this appointment
prohibits the inclusion of a large delegation.

In general, John suggests that the message be reduced in the number of specific pieces of legislation mentioned, the idea being that the President should in no way encourage the lame duck session of the 93rd Congress. By sending up a message containing a large number of non-critical legislative items, the President gives the Democrats ready made justification for a lame duck session. For our guidance, John offers these specific comments:

- (1) Page 9 Foreign Policy only mention Ex-Im Bank authorization. He is especially disturbed that emphasis is placed on defending an increased foreign aid assistance budget, while asking the taxpayers to tighten their belts and recommending cutbacks in domestic spending.
- (2) Page 10 Completely omit any mention of Illegal Alien legislation.
- (3) Page 11 Omit any reference to the three health authorizations that require extension this year. Also omit reference to the Comprehensive Health Insurance Plan.

Regarding the recently House-passed Federal Mass Transportation Act. John is unsure of what we mean be certain structural changes in that bill are necessary. John recommends that we be specific about the changes that are needed.

(4) Page 12 - Hit Energy Research and Development Administration harder. Mention Project Independence and the need to ensure that energy costs are brought under control. Include reference to Deep Water Ports legislation in this section.

(5) Last Page - Omit any reference to the Federal District Judges Act.

Milt Friedman should not proceed under the assumption that we think these suggestions of John Rhodes are mandatory changes in the text of the message but are only offered for his consideration and guidance.

- 2. Hays was forced into reporting an election bill but is unenthusiastic about reform legislation. It is believed he would like to forget the bill this year -- but needs someone else to blame!
- 3. There seems little hope of getting an acceptable bill out of conference. Rather than suffer the high visibility of a veto in the wake of Watergate, the President may elect to take some temporary criticism now by asking Hays not to pass a bill.

## III. TALKING POINTS

### CAMPAIGN REFORM

## I. Public Financing

The Administration proposal opposed any form of public financing for elections. Public financing, even in the form of matching funds, is said to favor incumbents at the expense of lesser known challengers. Current legislation would either resort to a matching system for Presidential elections (House bill) or Congressional and Presidential elections (Senate bill). The House bill would depend on the tax check-off device for matching funds for Presidential elections.

## II. Spending Limitations on Candidates

Expenditure restrictions are said to favor incumbents and hinder the flow of information necessary for the exercice of free choice. Both Congressional bills restrict spending. (Media expenditure limitations exist in current law.) The Administration proposal (S. 3261) had no limitations, and relied upon disclosure for the remedy.

## III. Campaign Contributions

Both Congressional bills and the Administration bill limited campaign contributions, but the Administration proposed limits were higher. (House limit: \$1,000 to any candidate; Senate: \$3,000 to any candidate; Administration: \$3,000 for Congress, \$15,000 for Presidential race.) The higher limits were designed to avoid giving an additional advantage to the incumbent.

### IV. Federal Election Commission

An institutional body is thought to be necessary to administer campaign reform legislation. It should be independent to be truly effective. The Congressional bills would have the Commission composed of one or more officers of the Congress plus a bipartisan group nominated by the majority and minority leaders of Congress. The Administration proposal would have the board composed of the two Chairmen of the national committees (non-voting) and five members appointed by the President and confirmed by the Senate.

#### STATE AUTHORIZATION

NOTE: If time permits, the President may wish to ask Hays to help on the State Department authorization bill which is now in conference.

The State Department authorization bill passed the Senate by a voice vote containing several objectionable amendments. Forecast among these are the Case Amendment requiring submission for Congressional approval of all overseas base agreements and a Diego Garcia amendment precluding expenditures of funds for that facility until the agreement had received Congressional approval. The Administration has strongly opposed these amendments in the past based upon the principle of separation of powers and the long standing authority of the President to conclude Executive agreements autonomously. The bill passed the House just before the recess and conferees will meet shortly after their return in September. Chairman Hays has indicated his willingness to help in removing most of the objectionable amendments in the Senate bill but has been reluctant to commit himself on the Case amendment and Diego Garcia. Your personal intervention would be extremely helpful in making clear the depth of Administration concern.

## Talking Points

- 1. In reviewing the status of the State authorization bill, I have noted the large number of amendments which restrict the President's authority to conduct our foreign policy. I am particularly concerned over the Case amendment and the restriction against going ahead with a modest facility on Diego Garcia.
- 2. The authority of the President to conclude base agreements is a matter of long standing and of particular importance in preserving an effective defense posture. The ability to negotiate these agreements successfully, hinges greatly on maintaining flexibility and is not a process which the Congress is very well disposed to control It is absolutely not my purpose to make any major increases in our overseas force posture -- quite the contrary. I do believe, however, -- and strongly -- that it is important to our interests in the Middle East and the Indian Ocean to have a modest facility for supporting Naval operations at Diego Garcia.

3. I intend to consult closely with the Congress as we move in this direction and very much want to take your views to take your views into consideration. I believe, however, that to allow Congressional modification and control over what are extremely complex political and technical issues would seriously compromise the conduct of our foreign and defense policies. Can I count on your support to help eliminate these two amendments?



I still believe Hays doesn't want a bill this year (unless he can write it himself), but will probably go through the motions to appease Common Cause, et al.

The probable issues that would arise would be attitudes toward public financing, expenditure and contribution limitations, and make-up of the supervisory commission board.

I would suggest Geoff Shepard get a position paper into the President for his views (if we don't already know them), and then schedule a meeting about September 11, 12 or 16.

I have also been told by other Members that Hays is very anxious to take advantage of the President's popularity with a substantive meeting.

However, Hays is key on this issue and could be helpful in getting responsible legislation.

#### I. PURPOSE

- Α. Background: This is the 3rd annual Congressional golf tournament. The President, as House Minority Leader, played in 1972, but was unable to do so last year. It is a private affair in response to an official invitation from the Secretary of the Air Force, Dr. John L. McLucas. Rep. Burt Talcott, R-Calif.. is chairman. Reps. Charles Wiggins, R-Calif., and Joe Karth are team captains for their respective political parties. The" Democrats won in match play in 1972, the Republicans won last year.
- B. Format: The President and his partner, Rep. Les Arends, R-III., (14 handicap) will engage in match play (best ball) in the overall competition for the Challenger's Cup awarded to the winning party. Play is 18 holes on the West Course (68.2 stroke rating).

Also in the President's foursome will be Reps. John Rhodes, R-Ariz, and Tip O'Neill, D-Mass., the Minority and Majority Leaders (not as partners).

SUBJECT:

Congressional Trip to The Peoples Republic of China

The Congressional trip to China (August 31 to September 14, 1974) came off without major incident.

The Fulbright group was well received; kept a rigorous and carefully planned schedule, meeting with diverse groups of PRC citizens and leaders.

The delegation spent time in Peking; Ta-Chai (a model agricultural commune in central China); Chang-Sha (a large commercial center in central China near Chairman Mao's birthplace); Hang-Chou (the East Coast resort city); and Shanghai.

Several important themes came through during discussions with PRC leaders in Peking and Shanghai:

- The PRC desires to continue efforts to normalize relations with 1. the U.S. under your new leadership.
- While stating the U.S. tends to overestimate Soviet military capability, the speed of USSR strategic weapons has been astonishing. The Soviet has not been saying much, but doing a lot. If the U.S. doubts this, ask yourself what the Soviet strength was 20 years ago in the Mediterranean, Middle East, Persian Gulf, Indian Ocean and the Pacific. We think the U.S. should maintain vigilance against the Polar Bear.
- We are more at ease with the U.S. than the Soviet Union "for the foreseeable future."
- Since World War II, U.S. has been well fed. The body of the U.S. has been well-maintained; there is much fat within the body of the U.S. Every advance of the Soviet strips a layer of fat off the U.S.
- Soviet intentions are primarily directed toward Western Europe and the U.S., rather than China as Soviets pretend.

- 6. The one million Soviet troops stationed along the Sino-Soviet border are not sufficient for a Soviet invasion of China. They would need two million troops to invade China and they can't spare them from Europe until they have control there.
- 7. Deep tunnels are being dug in rural and urban centers for civil defense against any Soviet nuclear attack. (An underground Chinese Great Wall.)
- 8. No diplomatic recognition with the U.S. is possible until resolution of the Taiwan Question. (The Chinese desire U.S. cutting of ties with Taiwan, of course.)
- 9. Chinese leaders do not believe in "detente" or a "generation of peace." They say they have had too much experience with wars. Wars have not stopped since World War II. Recently there has been war in the Middle East and Cypress.
- 10. They do not expect nuclear war, however, because "the people won't permit it." They do expect more conventional conflicts.
- 11. Criticism of the Soviets was frequent and vitriolic. The Soviets are bullying people too much, and the young people of China are full of anger toward the Soviet imperialist revisionists, we were told.
- 12. Whether the Soviets come by land, sea, or air, they will find China not easy to deal with. China has vast territory and great population, and we are ready at all times to take up weapons, the leaders boast.
- 13. Great disdain for the U.N. was expressed to repeated questions by Fulbright. "The U.N. is good for speeches, but what wars did the U.N. ever stop?" the Chinese responded to the Senator.
- 14. Arguments and questions between nations are inevitable. But China will not speak foul words against countries truly friendly to China; we hope the U.S. will criticize us when we are wrong.
- 15. Their attitude toward trade is one of "self reliance" but they want help in technology. They pointedly stated that their "self reliance" had enabled China to maintain stable prices, currency and financial balance.
- 16. All nations should withdraw all troops on foreign soil, however, Russia won't withdraw from Eastern Europe. So, as a practical matter, U.S. presence in Europe is a stabilizing force.
- 17. Chinese participation in the Vietnam War was characterized as restrained. They stated the "affairs of Vietnam will be settled by Vietnam."
- 18. The Chinese leaders recalled several times your visit to China and they feel a continuity of U.S. policy toward them.

19. Younger leaders in China have same attitude of friendliness toward the U.S. and will continue this policy after Mao and Chou are gone.

These expressions were voiced by Vice Premier Teng (reportedly one of two Vice Premiers running the country in Chou's absence), and Chaiao Kuan-hua, top ranking Vice Minister in the Foreign Ministry during three extended interviews in Peking.

The only minor flap of the trip occurred early during our stay in Peking when Vice Premier Teng Hsiao-ping announced the delegation would be unable to meet with Premier Chou En-lai because he was hospitalized and his condition had worsened.

This got in the press, several delegation members received calls from the United States, and the Chinese within several days announced to another foreign group that Chou was improved. I suspect the earlier medical report was given us to spare the delegation's feelings about not meeting Chou.

Senator Humphrey proved to be the most effective representative of our group. He was forceful in presenting American foreign policy.

Representative Frelinghuysen was also effective in our briefing sessions.

Chairman Fulbright handled his role as delegation leader in exemplary fashion, but his tone was apologetic and somewhat deprecating toward American views and actions during meetings with Chinese leaders.

We received word of your pardon of former President Nixon by shortwave radio via a Phillipine Voice of American relay deep in rural, central China.

Senator Humphrey's reaction was immediate and positive, as was Senator Fulbright. Only Representative Jordan (D-Tex), a Member of the Judiciary Committee, was critical.

It became apparent during the trip that you have a strong foreign policy and national security supporter in Senator Humphrey. I would recommend that you and Dr. Kissinger encourage the Senator.

I think the delegation represented yourself, Congress and the American people in a manner conducive to better relations with the PRC.

Richard Solomon, of the NSC, who has made five trips to China, and accompanied the Magnuson group last year, acted as our interpreter. He expressed the belief that the impact of this group (Fulbright) was much improved over a year ago when there were serious problems.

In general, I believe the Fulbright group was much impressed by many of the PRC achievements, particularly in agriculture. However,

the delegation's reaction to pronouncements by Chinese leaders ranged from doubtful to skeptical and highly critical.

There was a general feeling among our group that the trip was another step in the long road to normal bi-lateral relations with the Chinese.
