SUBJECT: Texas/Kansas Trip

Max informed me this morning that the President is willing to have Congressional delegations participate in the Texas/Kansas trip. The following guidelines have been passed on to us from the President.

Senate

Senator Tower will be the lead and it will be up to him who in the Texas delegation will be invited. It is my understanding that Bill is already working that matter with Tower. However Max has recommended that if Tower approves, the following be invited: Senator Bentsen, Congressmen Archer, Casey, Eckhardt, Brooks, and Congresswoman Jordan.

The Kansas leg of the trip, Senators Dole and Pearson should also be invited to participate in the trip only as it impacts in Kansas. Thus they can be invited to participate in the Topeka events but should not be invited to fly down to Texas with the President on that leg of the trip. We can extend to them an invitation to come back with the President from Kansas to Washington on Tuesday, February 11.

House

Pending Senator Tower's decision the above listed House Members can be invited to participate in the Texas part of the trip. They would not be invited to go to Kansas and participate there.

All Members of the Kansas House delegation should be invited to the Kansas part of the trip and extended an invitation to return to Washington with the President. In other words, they would not be invited to fly to Texas and then on to Topeka.

SUBJECT: Procedures for inviting Members of Congress on Presidential Trips

On the Miami/Ft. Lauderdale trip we found ourselves out front of the Advance Office on inviting Congressional participants before the President approved the final format. No problems arose, but to avoid any future mixups we have worked out the following procedures with the Advance Office.

1. Bob Wolthuis will attend the trip meeting in Red Cavaney's office. At this meeting they will discuss the involvement of Congress in the trip.
2. Wolthuis will notify Friedersdorf, Loen and Kendall, that the trip is under consideration and request recommendations concerning Members of Congress to go on the trip.
3. These recommendations will channel back through Wolthuis who will forward them to Robin Martin or Red Cavaney.
4. The Advance Office will include our Congressional recommendations in their trip proposal to the President who will then give his approval to our recommendations.
5. Once Presidential approval is given to the Advance Office proposal Wolthuis will be notified by Cavaney's office who will notify Loen and Kendall to extend the invitations.
6. The invitations should be coordinated by Bill for the Senate and by Vern for the House. Acceptances should be reported back through Wolthuis who will convey them to the Advance Office.
