I have received a letter from Mr. Wenceslao Corral, the Delegate General for U.S.A. affairs of the "Operation Plus Ultra" organization, sponsored by Iberia Airlines, asking for my assistance in procuring an audience with the President for the sixteen Peacetime Heroe children who will visit Washington on September 14, 1976.

The enclosed brochure offers background information of this organization (pages 8 through 12) as well as the individual story of some of the recipients of the Peacetime Hero award (pages 3 through 7).

The President has agreed to receive Prime Minister Miki on June 30 for a 60-minute office meeting at 11 AM and will host a luncheon in his honor at 12:30 PM, along the lines of the luncheon for Danish Queen Margrethe. It is our understanding that the Japanese Government wishes to present its major Bicentennial gift of a \$3 million check to the Kennedy Center for a new studio theatre on the occasion of the Prime Minister's visit to Washington. In this regard, the White House is agreeable to a brief and small ceremony in the Rose Garden following the Oval Office meeting for the purpose of the presentation of the check. We understand that the Minister in charge of the Prime Minister's office will want to present the check and we believe it would be appropriate for him to present it to Roger Stevens. ARBA Administrator John Warner could be in attendance and the prese could be called in to view the presentation. The President will be present for the ceremony but should not be the recipient of the check.

The Department is requested to confirm acceptance of the meeting and luncheon. At the same time, the Department should convey to the Japanese the White House desire to have the ceremony follow the lines indicated above and seek their concurrence. It should be made clear that the presentation ceremony is to be brief, would conclude following presentation of the check, and attendance should be strictly limited.

Please provide a suggested guest list for the luncheon to include spouses, no later than June 17. The Japanese party should be kept to 12. We would also appreciate knowing as soon as possible whether Mrs. Miki is planning to accompany the Prime Minister.

We will need the briefing material for the Miki visit no later than June 24.

As you know, the Japanese Government has agreed to contribute \$3 million to complete the studio theatre above the Eisenhower Theatre at the Kennedy Center.

Would it be possible for the Japanese Ambassador to present the check for this purpose directly to President Ford at the White House?

There would be about 12 to 15 people in their official party, some of whom would fly over from Tokyo for the event. They would be accompanied by a Japanese press corps of about 25 reporters. In addition, we would expect at least 25 Trustees from the Kennedy Center and several other appropriate guests. The ceremony should not take more than 15 minutes. The Embassy has suggested that any time between June 10 and June 15 would be suitable, at the President's convenience. However, they would appreciate some advance notice for those who would be planning the trip from Tokyo.

For your information, on July 9th, the Japanese Government will be presenting to Secretary Butz 100 bonsai trees for our Arboritum. I understand that these trees are from 200 to 300 years old and are invaluable. In addition, they will present 100 cherry trees to the District of Columbia in September, as well as hundreds of other cherry trees to the cities of San Francisco, Los Angeles and Seattle. Certainly these fine gifts are the most important the United States has received for the Bicentennial.

I appreciate very much your giving this your personal attention, and I will look forward to hearing from you.

I was discussing it with Mrs. Buchen -- and she feels that since the painting was to Mrs. Ford, it should be acknowledged in the East Wing. And especially because it has been such a long/since it was received, very warm letters should be sent.

I had received the call from Rogers Morton's office asking for a copy of the acknowledgment letter -- since they understood it had not been acknowledged (call from them on June 16th).

I called Angie in his office this morning to let them know that we had located the Atlas and the painting -- and asked her the reason for wanting a copy of the acknowledgment.

She said that Lord Montagu is a friend of Mr. Morton's -- they spent a weekend together in Williamsburg. Lord Montagu wrote to Mr. Morton and said they had sent over the Atlas to the White House and said they hadn't heard whether it had been received. She read one paragraph to me:

"One point, however, we did send the President
a beautiful Atlas, together with a picture for
Mrs. Ford, via Mr. Buchen, who no doubt has
presented the gift. it would be nice if we could
some time have a letter from the President
acknowledging the gift as I am sure you will
appreciate we would like to place it on record in
our Missions Archives." (From a letter dated June 1, 1976)

The address on the letter to Rogers Morton was:

Mr. Mitler said since the names of the Lords on both items were the same that he could just write an acknowledgment for both items.

Mrs. Buchen feels they should acknowledge Mrs. Ford's gift from the East Wing. Mr. Peacock, as well as Morton's office, feels the acknowledgment should come from the President.

Since they didn't have the painting, Mrs. Buchen suggested I call Don Peacock, who had arranged the trip for the British Lords, and ask him to describe it so we could tell Mitler's office what to look for.

This is in reference to Jack Marsh's request for guidance regarding the disposition of the Bicentennial gifts which are now under the control of Milt Mitler's office.

These gifts were accepted on behalf of the people of the United States in order to avoid the appearance that the President was profiting therefrom. It is fully consistent with their acceptance to send them to the future Ford Presidential Library. However, I believe we should consider their title already to be vested with the United States, and thus title not be governed by any legal instruments that are to be used for the President's personal papers. Display in the Library is consistent with our handling of foreign gifts which are also property of the United States. While the Library will have authority to loan such gifts to other institutions, it will in the future have to discuss with Archives ways in which it might be able to donate such gifts to other museums. There is no need for immediate resolution of that particular question.

If the University does not have sufficient space for interim storage of these Bicentennial gifts, we should be able to arrange with Archives for interim storage since this is U.S. property.

Jack, up to this point we have not considered what should be done with the Bicentennial gifts. Currently, all are on display at the National Visitor Center (Union Station), except for two which are at the Smithsonian. In previous conversations, I have been told by Smithsonian officials that they have no place to store the gifts nor do they want them at the present time. These gifts have been accepted on behalf of the nation and are under my supervision as opposed to other gifts which Marge Wicklein has and which are placed into the archives and then made available for the President's Library.

There are many gifts which are quite valuable and others which have sincere significance because of the event they commemorate. While they really should be kept on display, I have no way of being certain how long the current display can last. Originally, when arrangements were made, I talked in terms of calendar year 1977.

There are some options which should be explored and possibly Phil Buchen should be asked for an opinion.

- 1. Permit the President to select Bicentennial gifts for his Library with the balance stored away or given to museums and other public interest areas on permanent loan.
- 2. Distribute all gifts to museums, etc., on permanent loan or outright donation.
- 3. Try to convince the Smithsonian to arrange for a Bicentennial gift display sometime during 1977 or as soon after the end of the Visitor Center display.
- 4. Maintain the display at the Visitor Center as long as possible and then store the gifts in the archives for future consideration.
- 5. Do nothing more than what has been done and let the next administration make the decision for future disposition of the gifts.

My personal option would be the first. Since he is the President who served during the Bicentennial year, I believe President Ford's Library should contain a selection of Bicentennial gifts.
