Dear Mr. Casselman:

Since January, 1973, a federal grand jury organized by the United States District Court for Maryland and supervised by attorneys in this office, has been conducting a criminal investigation into allegations of misconduct by past and present public officials of this State. During August of 1973 it became necessary for this office to request a review of existing records which would disclose when certain identified persons may have visited former Vice President Spiro T. Agnew at his offices in the White House or in the Executive Office Building from January 21, 1969, up to August 10, 1973. This request was relayed by me to then Assistant Attorney General Henry E. Petersen who, in turn, spoke with Leonard Garment at the White House. Mr. Garment, I was told, arranged for a search of the appropriate records and the results of that inquiry were furnished to this office thereafter by the United States Secret Service.

Since the time that this relevant data was made available to the Maryland federal grand jury it has continued to pursue its investigation on several different fronts. Part of the continuing inquiry relates to the activities of J. Walter Jones, Jr., who, the grand jury has reasons to believe, visited Mr. Agnew at one of his vice-presidential offices on April 20, 21, or 22, 1971. It is, however, impossible to discern from materials which were turned over to us earlier by the Secret Service whether this supposition is correct. We have also been told that, if Mr. Jones was the bearer of a special pass such as the type distributed to persons whose names may have been on what was called the "access list," it is unlikely that his name would appear in the registry of visitors for any of those days.

It is imperative that the grand jury learn whether or not Mr. Jones' name appears on any of the diaries, logs or records reflecting visitors to the former Vice President on those three dates and, if not, whether Mr. Jones was the possessor of some sort of identification which would explain the omission. To that end I write to ask that another, follow-up examination of existing records be undertaken by the Secret Service and that we be advised of the results. We will, of course, relay the information to the local grand jury.

From my notes I can reconstruct for you the substance of prior phone conversations which led to the original production of the investigative material, if it becomes necessary for you to confirm any factual details with other people involved in that earlier activity. I do recall that Special Agent Louis Simms of the United States Secret Service in Washington was personally involved with the original request in some way.

I trust that this letter will serve as an adequate predicate for this office to obtain clarification of what to this point is a factual ambiguity. If a need for additional background arises, please feel free to get back in touch. Thank you for your customary cooperation.

Pursuant to the procedures established by Judge Richey's temporary restraining order now outstanding in Nixon v. Sampson and consolidated actions, you have consented to the Special Prosecutor having access to certain Presidential tape recordings for use in connection with the trial of United States v. Connally. You have requested, however, that the Special Prosecutor issue a subpoena for these recordings. We have acceded to this request, and will be serving a subpoena today, but only upon the assurance from you that issuance of this subpoena will not constitute a waiver of any of the legal positions we are asserting in Nixon v. Sampson. In particular, you have assured us that issuance of the subpoena will not constitute any concession that the November 9 Agreement is not valid, that Mr. Nixon is the owner or legal custodian of the materials now located in the White House relating to his Administration, or that Mr. Nixon is the proper respondent for any subpoena for the materials.

We understand that you will make copies of the subpoenaed recordings available to us in the immediate future. As you are aware, if it becomes necessary to introduce any of the recordings into evidence at the trial in United States v. Connally, we will require the originals for purposes of authentication under procedures similar to those employed in United States v. Mitchell, et al.

As you perhaps are aware, this Office currently is preparing the above-captioned cases for trial. The case of United States v. Frank DeMarco, Jr. currently is scheduled for trial to commence on September 16, 1975. The case of United States v. Ralph G. Newman currently is scheduled for trial to commence on October 28, 1975.

In preparing for these trials, we have determined that there are certain documents among those papers claimed by former President Richard M. Nixon to constitute his personal property which might be relevant to these cases. These fall into two categories:

- (1) Three memoranda in the files of former White House aide Peter Flanigan; and
- (2) White House travel vouchers relating to trips made by former White House aide Edward L. Morgan in 1969 and 1970.

The documents in Mr. Flanigan's files have been described to us as follows:

(a) A memorandum dated between November 28, 1969, and December 12, 1969, from Mr. Flanigan to Mr. John Ehrlichman stating, in part, "there is one bit of information I need to know, the kind of institution to which

the President is planning to give his papers" and referring, in general, to the former President Nixon's pre-Presidential papers;
