Several weeks ago a legal researcher came to the National Archives seeking access to the records of the Office of Emergency Preparedness which had been accessioned into Record Group 396 of the Archives of the United States. He was referred first to the Natural Resources Branch, Civil Archives Division, where the accessioning records indicated that the sought-after records were allocated for eventual deposit in the Richard Nixon Presidential Library. He was then referred to the Office of Presidential Libraries to determine the whereabouts of the sought-after records.

A staff archivist searched for the records in stack area 1W-2 and was unable to find the materials. We supposed that the materials might be among those non-Presidential materials left in stack area 2W-2 at the time that that stack area was secured and control turned over to you. I therefore laid aside the case until your projected visit to the National Archives Building in conjunction with completing the location register of materials in 2W-2. When your assistant, Betty Karabatsos, and members of the NLN staff came to the National Archives on Wednesday, December 11, 1974, to open stack area 2W-2 and proceed with the location register work, my assistant reminded me that we should take the occasion to determine whether the sought-after record of OEP was located in that stack.

As you know, I have professional supervisory responsibility for the work of archivists on the NLN staff as well as a delegation from you concerning the inventorying of various Nixon materials. I therefore proceeded to visit the stack area where the staff archivists were working on the location register to check their work and thought it convenient at the same time to ascertain the location of the sought-after OEP record. Seeking the location of this record is not unrelated to the creation of the location register by the NLN staff. We could not easily find the OEP record in 2W-2 so we returned to 1W-2 and made a further search there. Not finding it in 1W-2, we doubled back to 2W-2 and determined to walk every aisle in search of the subject box.

During the early part of this search on 2W and 1W, Betty Karabatsos was not present, but by the time we returned again to 2W Betty was

back on the scene. I explained to her (perhaps inadequately) that I was trying to ascertain the location of a box of accessioned Federal records unrelated to the Presidential materials.

In the course of the more detailed search of 2W-2, we found the subject box of OEP records, properly labeled. I asked Dick McNeill to remove the box from the shelf and open it in order to determine whether the desired file folder was contained therein. We opened the box, found the folder, and estimated the quantity of material related to that folder. We then closed the box, reshelved it, and departed from the stack area with Betty Karabatsos.

The archivists who worked with me on this search were Jim Byers and Dick McNeill. We did not examine the informational content of the papers and removed no papers from the container. Also we removed no materials from the stack area.

In undertaking this search, I was clear in my mind that the desired materials were records accessioned into the National Archives, not Presidential materials subject to the court order of Judge Richey. The basis on which I made the determination is the accession folder containing all documentation relating to the accession of the material into the National Archives. There are many other materials, vast quantities of materials, that were located in stack area 2W-2 at the time when control of that stack area was turned over to you. They are not subject to the Judge Richey court order since they are not related to Presidential materials which are the subject of that court order. I recall that I informed you of that fact shortly after you assumed control of the area.

In order to be able to locate all boxes stored in the areas under GSA control, we need to refine the inventories delivered to all parties on November 13, 1974. Primerily, we need to return to the 289 pallets (in OROB) each containing 24 cubic fact of Central Files documents and identify which boxes are on each pallet. We need to do the same type of work in stack 2W2 at the National Archives Building. Subsequently, we need to convert the information to a location register organized by office of White House staff member.

Thereafter we should be able to locate any box or Central File folder which is requested within a matter of minutes. This work would normally have been done prior to delivering the inventories on November 13, but time did not permit its completion.

In the process of doing this work, no boxes or files will be opened and none will be removed from the areas under our control.

Administrator Sampson has approved our proceeding with this project subject to 72 hours notification to both of you.

I have discussed this with you previously, and I believe it meets with your approval. Therefore, I would appreciate hearing from you at the earliest possible moment.

Relocation of Nixon Materials

I. What should be done?

The Nixon historical materials should be moved from the Executive Office Building to the Washington National Records Center at Suitland, Maryland. To accomplish this, an amendment to outstanding court orders should be sought (1) to allow the materials to be moved and, (2) to allow necessary preservation measures to be undertaken.

- II. Why should it be done?
 - A. Current storage conditions of the Nixon materials are inimical to the preservation of the materials:
 - 1. There are no temperature and humidity controls.
 - 2. There are no adequate fire prevention devices.
 - 3. A large portion of the material has been packed for shipment for over a year, strapped on pallets where the lower boxes are being crushed.

All of these conditions would be corrected in the Suitland records center.

- B. Current access restrictions prevent critical preservation measures. Tapes should be rewound, papers should be shelved in acid-free containers, the still photographs should be examined for deterioration and placed in protective envelopes. Failing to take necessary preservation steps now risks damage and loss.
- C. Storage space in the Executive Office Building is costly and prevents the current Administration from using part of its normal office space. The present location has been convenient for the lawyers involved in litigation and investigation; however, indications are that access for such purposes is largely completed. In the Suitland records center the materials are mere minutes away from downtown Washington and the space there is less expensive and does not hamper White House administrative functions.

III. Will the material be secure?

The materials will be stored in a caged area certified at the level of top secret, within a vault certified at the level of top secret. Access to the bay area in Suitland is limited; access to the vault is restricted to those with clearances and a need for access; access to the cage will be limited to conform to the court orders.

In accordance with the attached correspondence from Messrs. Miller and Mortenson, Counsel for former President Nixon, this will authorize entry, beginning January 10, 1975, into Room 175 1/2 (Conference Room) of the Old Executive Office Building. The purpose of this request is to separate "Presidential materials of the Nixon Administration" from papers and other materials contained therein that do not fall within this category, pursuant to the procedures described below. Authorization is hereby given to pack these materials following their segregation and inventorying.

As described in the attached memorandum to me from Mr. Thomas P. Wolf, dated January 8, 1975, this work will be undertaken by archival and other employees of the General Services Administration, who will make the necessary segregation consistent with the standard archival definition of Presidential materials provided in 44 U.S.C. 2101. It will not be necessary, however, for a member of my staff to be present at all times during such entries.

A similar procedure of segregation, inventorying and packing will also be undertaken at this time in Room 175. Once materials therein have been packed, they are not to be removed from this suite without my express written authorization. I am enclosing herewith a request, dated April 15, 1975, received from National Archives that they be permitted to move certain pre-presidential materials and administrative files from a currently restricted area to one to which they will have access. These items are needed for current government business.

I have discussed the above request with Mr. Irwin Goldbloom of the Justice Department and Stan Mortenson, Counsel for former President Nixon. They agreed to the following proposal, subject to your approval.

We need your permission to enter the area where these materials are now stored, Stack 2-W-2 in the National Archives Building, and to identify and inventory the items which are to be moved. Subsequent to completing this inventory, we propose to inform all parties involved in <u>Nixon vs. Sampson et al</u>. that we plan to move these materials to a new area, also under the control of General Services Administration, for current government business. We will attach an inventory regarding our planned move.

If the above meets with your approval, I would appreciate your doing the following:

- 1. Authorizing me, in writing, to proceed with the access and inventory;
- 2. Designating a member of your staff to be present or waiving your right to be present; and
- 3. Informing Mr. Nixon, or his agent, of the proposed action and confirming his waiver to be present.



We would appreciate permission to proceed with this as soon as possible.

- 1. Identify and remove certain pre-presidential materials which are not subject to Judge Richey's restraining order of October 21 and 22, 1974. At the time these court orders were issued, these materials were stored in the same location as some Presidential materials, and the area was secured prior to our removing the pre-presidential materials. These are now needed for on-going archival processing, and we need to move them to an area, under GSA control, where the archivists will have unrestricted access.
- 2. Identify and remove NARS administrative office files which do not fall under the court order and which were also left in the restricted area on October 22, 1974. These are also needed for on-going archival purposes.

We would appreciate your expediting the necessary steps to achieve this request.
