

As we discussed, I approve the waiver of background investigations and personal data statements for the following members of the new Federal Election Commission:

William L. Springer Neil Staebler Vernon W. Thompson Thomas E. Harris Joan D. Aikens Robert O. Tiernan

With the exception of Mr. Springer, the above persons have served as members of the Federal Election Commission for the past year and were previously approved by both the House and the Senate. Mr. Springer was the subject of a background investigation prior to appointment and confirmation by the Senate in 1973 for membership on the Federal Power Commission. The Special Prosecutor has orally advised that he has no information which would be relevant to the proposed appointment of Mr. Springer. The FEC General Counsel also advised a member of my staff that financial data statements are filed by Commission members with the Chairman of the CSC in accordance with E.O. 11222. In view of the unique nature of these appointments, and in order to avoid even the appearance of Administration pressure on the FEC, our customary checks are unnecessary. However, this waiver is intended only for this particular situation and should not be considered for future appointments.
