The purpose of this memorandum is to recommend the appointment of a well-qualified individual as Associate Judge, District of Columbia Court of Appeals vice Chief Judge Gerard Reilly who reached mandatory retirement age of seventy years old on September 27, 1976.

We have received three candidates for this position from the District of Columbia Judicial Nominating Commission, a new body established in 1973 by the Home Rule Bill (P. L. 93-198) to fill judgeship vacancies in the District of Columbia. Within 30 days of the occurrence of a vacancy on the District of Columbia bench, the Commission must submit three nominees to the President; if the President fails to nominate one of the three within 60 days, the Commission makes the appointment with the advice and consent of the Senate. The 60-day time limit expires on October 27, 1976.

Theodore R. Newman, Jr. - 42 years old; A. B. Brown University, J. D. Harvard Law School. Since 1970 he has been Associate Judge, Superior Court of the District of Columbia. He began his legal career, as a First Lieutenant in the United States Air Force, when he was assigned to the Office of the Staff Judge Advocate (1958-61). After completing his military tour of duty he joined the Civil Rights Division, U.S. Department of Justice as an attorney in the General Litigation Section (1961-62); he then joined the law firm of Houston, Bryant and Gardner (Washington, D.C.) as an Associate (1962-68). In 1968 he joined the firm of Pratt, Bowers and Newman (Washington, D.C.) as an Associate remaining with this firm until his appointment to the Superior Court of the District of Columbia.

It is expected that if appointed to the Court of Appeals the District of Columbia Judicial Nominating Commission will designate Newman as Chief Judge.

The President today announced his intention to nominate Eugene V. McAuliffe, of Jamaica Plain, Massachusetts, to be Assistant Secretary of Defense. His area of responsibility will be International Security Affairs. He will succeed Robert Ellsworth who became Under Secretary of Defense on December 22, 1975. Mr. McAuliffe has been Ambassador to Hungary since March, 1975.

Ambassador McAuliffe was born on November 25, 1918, in Boston, Massachusetts. He received his A.B. degree from Boston College in 1940. He attended the National War College from 1962 to 1963. He served with the United States Army from 1942 to 1947.

In 1948, Ambassador McAuliffe entered the Foreign Service and was assigned as Consular and Political Officer in Berlin. He became Executive Assistant in 1954 and later Chief of Reports and Operations Staff of the Executive Secretariat for the Department of State. From 1958 to 1962, he was assigned as Political Officer in Mexico City.

During the period from 1963 to 1966, Ambassador McAuliffe served as Director of the Office of Public Services and then Executive Secretary of the Policy Planning Staff for the Department of State. He was Director of Atlantic Political and Military Affairs for the Department of State from 1966 to 1968. He served as Deputy Chief of Mission with the personal rank of Minister in Madrid, Spain until 1970. From 1970 to 1972, he was a Political Officer, Supreme Headquarters, Allied Powers in Europe. He was Deputy Chief of Mission of the United States, North Atlantic Treaty Organization in Brussels beginning in 1972 until his appointment as Ambassador to Hungary.

Mr. McAuliffe is married to the former Winifred Gallivan and they have eight children.
