

This is in response to your inquiry concerning the policy for handling invitations for honorary membership in Masonic and Shrine organizations.

In my memorandum to you of October 31, 1974 (at Tab A), a listing was included of all such invitations that had then been received. This listing was marked for approval at your discretion and we were advised that you did not indicate acceptance for any of these organizations. Accordingly, the general policy has been to have the Correspondence Section turn down such invitations. However, when you have been involved with the organization, such as your attendance at a ceremony held by the George Washington Masonic National Memorial Association, or a meeting with the potentate of a shrine, you have accepted the invitation to serve as an honorary member.

There is no legal or appearance problem presented if you wish to accept these invitations, as long as they do not involve fundraising activities. It is my understanding that while Vice President you generally accepted all invitations for honorary membership in such organizations. The only arguments against acceptance are the relatively large number of such invitations that can be expected and uncertainty as to how they will use your name.

DECISION:

Option A. Continue the present policy of accepting invitations for honorary membership only where you have been personally involved with the individual organization, subject to your approval on a case by case basis.

From May 17 to 22, 1976, Washington will be the scene of the Seventh Inter-American Music Festival, held under the auspices of the General Secretariat of the Organization of American States, the Inter-American Music Council, and the Inter-American Association of Music Critics, and supported by a grant from the National Endowment for the Arts.

Like its predecessors, the Seventh Festival will bring to this city outstanding soloists and ensembles from throughout the hemisphere. Programs will be made up of works by leading contemporary composers from North, Central, and South America, many of them especially commissioned for the Festival.

The first six festivals, held at three-year intervals, won unanimous critical acclaim for their contribution to public appreciation of musical accomplishment in the New World. I am confident that, like them, the Seventh Festival will both stimulate, and provide needed international recognition for, creative and performing talent from all parts of the Americas.

I hope, therefore, that you and Mrs. Ford will be so gracious as to accept the invitation I now extend to serve as Honorary Chairmen of the Seventh Inter-American Music Festival of Washington.
