The Michigan Association of the Professions delegation will be in Washington, D.C. from noon of April 28, 1975 to 6:00 p.m. of April 29, 1975. (You are familiar with this delegation, having met with us for so many years in your Congressional capacity.)

Our purpose is to recommend the early establishment of a White House Conference on the Professions. From such a conference could evolve many programs to avoid such difficulties as the present professional liability crises. Not the least of such programs might be a National Foundation of the Professions similar to that which you supported in a bill introduced by Congressman Chamberlain, et al., in 1972 and 1973.

**EACKGROUND:** 

The idea for the American Issues Forum was first suggested by Walter Cronkite in late 1973. The Forum consists of a national calendar of topics for discussion during the Bicentennial year, comprising the major historical issues that bear directly on the future of the country. The distinguished Americans who banded together as a national planning group to form the American Issues Forum for the observance of the nation's Bicentennial. The program which will cover a nine month period, was developed under the auspices of National Endowment for the Humanities with the formal "co-sponsorship" of ARBA.

The Forum invited the participation of all American citizens nationwide, through the media, through national and local organizations, through professional and labor organizations, in their schools, churches, community and neighborhood groups and families. It will be the largest single attempt at national dialogue, planning and education ever mounted in this or any other nation.

The American Issues Forum will be looking at America, asking what is America, how did it come to be what it is and what are the problems that disturb each one of us Americans today. They shall be looking, sometimes, at the past to find out where we came from. They will be looking at the traditions of America -- and asking about ways of renewing those traditions -- or of changing them. We shall sometimes find diversity and discord, compromises and conflicts. Doubtless we shall also find some disparities between out ideals and our practices, evidence of failure and mere muddling through. But we shall also find ideals that move us and prospects that excite. And we may finally find the continuity of our experience, a sense of our tradition, to affirm and renew.

The subject, then, will be as broad as America. And as immediate as our own lives.

This is not a Federal program but a perfect example of private/Federal partnership with Governments merely coordinating and advancing interest developed in the private sector. It is designed for everybody as witnesses by the large range of groups and national organizations which have already committed themselves to developing programs on the issues of the Forum Calendar.

Presidential participation in the announcement of this program would focus attention on one of few national Bicentennial programs.

Dear Mr. Buchen:

Several trade publications reported recently that the President has agreed to meet with representatives of the pension industry on May 7, and that the delegation has been named by the Association of Private Pension and Welfare Plans.

As much as we welcome this meeting and the opportunity for an exchange of ideas between representatives of our industry and the President and his advisers, we would like to draw your attention to the fact, that the members of the delegation, as well as the Association of Private Pension and Welfare Plans, represent large pension plans and actuarial firms administering such plans.

The conference does not seem to have any representation of the small employer plans and of actuarial firms specializing in the administration of small plans. Yet, 83% of all U.S. employees are employed by firms with fewer than 1,000 workers.

From my long personal acquaintance with the President, I am sure he would like to obtain as broad and complete a picture as possible in these meetings.

I would like to suggest, therefore, that a separate meeting be scheduled at a later date with representatives of small employer plans, and of actuarial firms which administer small plans, to give them an opportunity to discuss the impact of the recent pension legislation on their plans, and the particular situation of small employer plans, with the President and his advisers.

I have discussed these views with Rep. VanderVeen, and he suggested that I contact you. If you feel that they have some merit, I would appreciate hearing from you, and I would be very happy to submit some recommendations regarding representation of the small employer plans.

- SUBJECT: Presidential Bill Signing Ceremony for the Securities Reform Act of 1975

As we discussed on the telephone today, Congress is about to approve and send to President Ford a bill many people believe to be the most significant legislation affecting our capital markets in over forty years. Because of the historic aspects of the occasion, the Commission respectfully requests that the President commemorate the event, and the three years of effort that have gone into this legislation, by having a bill signing ceremony on Saturday, May 3, 1975.

The legislation will significantly enhance the ability of this Commission to establish a National Market System for the trading of securities. At a time of uncertainty and doubt on the part of many investors, and also at a time when the capital-raising needs of United States companies have never been greater, the Administration of President Ford, along with the Commission and the Congress, joined forces in implementing legislation that will bring increased order and understanding to areas where there previously existed doubt and uncertainty.

Previous attempts in the last Congress to amend the Securities Exchange Act of 1934 and other laws this Commission administers met with opposition from both government and industry quarters. Through the good will and sincere dedication of almost all concerned, the problems and obstacles deterring passage of this important legislation were overcome, as evidenced by the fact that both the House and Senate versions were unanimously reported out of the Interstate and Foreign Commerce Committee and the Committee on Banking, Housing and Urban Affairs.

The floor votes were just as compelling. In the House, on April 24, 1975, H.R. 4111 was approved by the lopsided vote of 376 to 13; the full Senate approved S. 249 the preceding week, on April 17, 1975, unanimously, by voice vote.
