


- -- By choosing to pursue this constitutionally prescribed course I believe I have chosen the course which is in the best interests of the Nation. Each time I have entered into diplomatic negotiations, I have done so with an eye towards the generations which follow us. History sometimes demands of us dimensions that we don't always appreciate in the short-term. But to ignore those

dimensions is to invite permanent injury in the avoidance temporary sacrifices.

- -- I defend the total context of my actions because that is my human instinct. But I defend them, more importantly, because I am only a visitor in a revered institution of our democracy. To believe this, as I do, permits no other direction to take.
- -- These will be difficult times. They will be times of testing. There will be diversions. But let us proceed with our work.
