Dear Phil:

There was an article in the paper this morning to the effect that the President and Mrs. Ford were dissatisfied with John Ulbricht's portrait of him and that they were now looking for an artist with more realistic and traditional style. This is a very apt description of Zoë's work.

As you know, Zoë has been doing portraits all her life and, although she has specialized in children, she has also done many adults, including the former president of Cuba, Dr. Ramon Grau and his First Lady. As examples of her work, I am enclosing photographs of oils she did of Judge Starr and of me. Also a small photo of the portrait of Ambrose which hangs in Kent Country Club. This is a pastel, as is the other small one of Lili Damita, the former wife of Errol Flynn.

Phil, I am not using our friendship to solicit a commission for Zoë. In fact, I have insisted that she do less work and enjoy life more and have absolutely refused to let her have any exhibitions or accept any gallery commissions. Nevertheless, I know she would be happy and honored to do the President's portrait, not only because he is an old friend of mine but even more because of her great admiration of him. In fact, she would be delighted to do it without any obligation or compensation whatever.

We plan to be in Washington on Monday, June 28th, and could arrange to start the portrait at or around that time. Zoë works from photographs plus a color sketch and the sitting usually takes less than half an hour. We could, of course, make a special trip to Washington at a later date, if the last of June is not convenient.

Please tell the President that I have written to you instead of him only because I know how very busy he is at this time. Zoë joins me in warmest regards to you and Bunny.
