Subject: Tax Assistance at the White House

Over the past several years, IRS taxpayer assistance at the White House has been provided by an IRS representative visiting there on a request basis. We find it difficult to justify maintaining these special efforts, because of the low volume of inquiries and the close location of the IRS office, at 1201 E Street, N.W.; and we propose to eliminate them.

We believe that most White House employees can receive timely, satisfactory service at the E Street office, which provides a full-time walk-in taxpayer assistance program. Additionally, the IRS offers at least 40 hours of service each week, both on the toll-free telephone system and at its other permanent walk-in locations in the metropolitan area, as well as extended hours during the filing season. I have attached a schedule of IRS Federal Tax Assistance - 1975.

I hope this information will be of assistance to you in informing White House employees about how best to get the tax help they need.
