One of World's Most Prized Swords Is

ON the desks of 400 of the most distinguished men on earth, even in remote corners of the world, a visitor is apt to see a silver paper cutter that is a miniature reproduction of the dress sword worn by Lord Nelson. Presidents, kings, shahs, princes, prime ministers, great military leaders, ambassadors, cabinet members, chiefs of staff own them.

Each silver sword is evidence that the owner has spoken before the Calvin Bullock Forum on the thirty-third floor at 1 Wall Street. No other person may own the sword. That goes for Hugh Bullock, head of the House of Bullock, that has specialized in investment management the past sixty-two years. And it goes for all his top executives, too. The sword must be won by speech.

Nor may any man or woman own two of the swords, although some speakers have

house category at Bullock's, and they call it that. Forgiveness is rare.

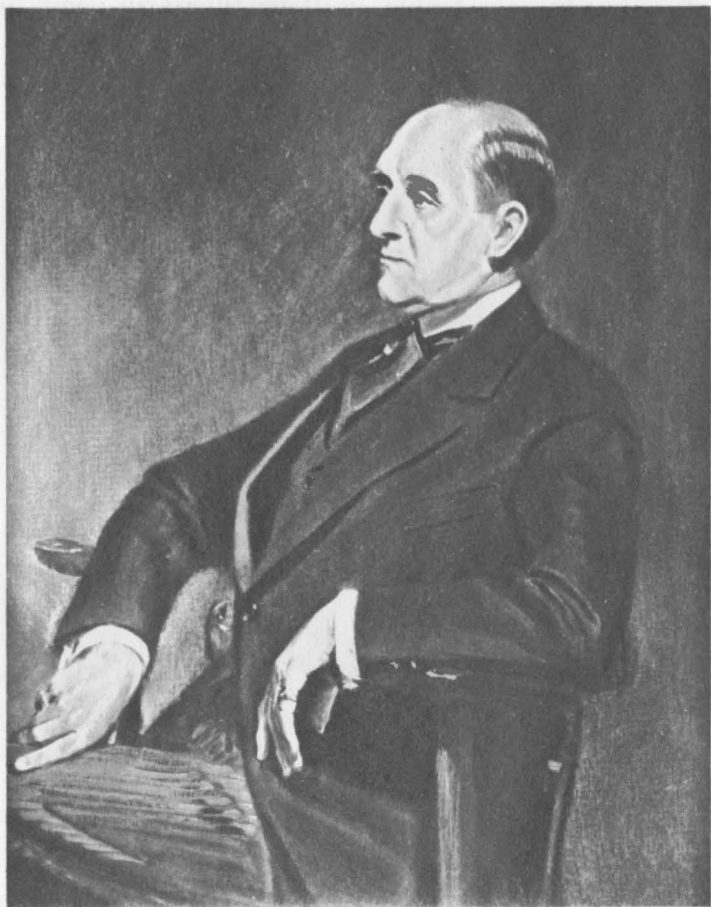
Every forum speech starts at 4 P. M., at the close of the Wall Street day; each ends at 4:30 o'clock, and an electronic clock on a special I.B.M. rostrum—a rising, tilting, falling gadget, all button controlled, gift of the late Thomas J. Watson—calls irrevocable halt. Questions may be asked for fifteen minutes after that, but not one moment beyond.

Women have addressed the forum—Lady Astor and the late Anne O'Hare McCormick, among others—but women may listen only when there are women forum speakers, as when the Queen of Greece appeared with her consort. The ban traces to 1945 when the commando chief of the Frasers, Simon Lord Lovat, was to speak.

THIS unique Wall Street institution was founded by Mr. Calvin Bullock thirty-six years ago. The eminence of its speakers and audiences has given it an international reputation. A partial list of speakers appears within.

Lectures are usually held in mid-week at four o'clock sharp, last thirty minutes, and are followed by a fifteen-minute question period.

Everything said is off the record. This permits unusually intimate addresses and discussions.

Subjects are confined to political, economic, scientific or military questions, in short those matters that would profoundly affect the business world.

The sad death on June 21, 1944 of the Forum's beloved founder determined its continuance by his associates as a Memorial to him. His perfect counsel as to choice of speaker, subject, and audience can never be replaced. But his important contribution to adult education will long be remembered.

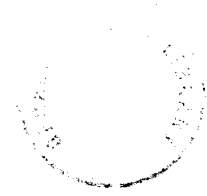

BACKGROUND

The Calvin Bullock Forum is a gathering of many of the financial leaders of Wall Street. The Forum is sponsored by the Calvin Bullock organization, which manages a series of mutual funds, among other matters. Discussion has, by custom, always been "off the record" in order that the group may enter into frank and honest discussion about the country's economic situation and outlook. Your reply of July 6, 1973, indicated your acceptance of the Bullock invitation to address the Forum.

In reviewing this acceptance, it is felt the following should be given consideration:

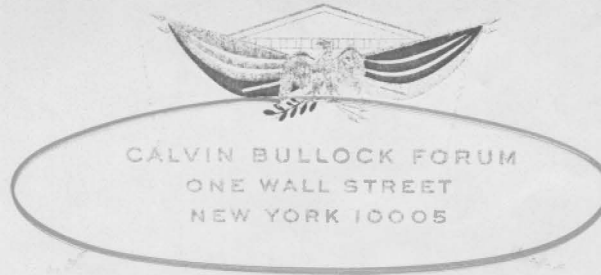
1. To meet their scheduled time frame, your departure on Monday from the Capitol can occur not later than 1:00 pm. This may cause some conflict with your confirmation hearings.


It has been several years since you last honored us with a visit. Do you think you could come up to New York again as our guest on one of the following Fall dates: October 31st, November 12th or November 27th?
