No letter of invitation can be located in our office. This group is an auxiliary unit of the RNC Spanish Speaking Advisory Committee. Overall Chairman of the RNC Spanish Speaking Advisory Committee is Congressman Manual Lujan, Jr., of New Mexico.

I called Congressman Lujan on 6/10 and told him we definitely had the Vice President scheduled elsewhere for the same time that this meeting was being held. He was aware of that fact and was also aware of the attached letter signed by Fernandes. I asked Lujan if he could be of assistance in taking care of this matter right away as we did not want this group to be disappointed because of misinformation. He agreed and said he would take immediate action.

I just received another telephone call from the man in charge of the mechanics of the meeting whose name is Bouchey, who said Fernandes had just called him to build the meeting around Vice President Ford. HOUSTON (AP) - THE MAN WHO DIRECTED FUND RAISING FOR PRESIDENT NIXON ANONE SPANISH-SPEAKING GROUPS PROFITED FROM A GOVERNMENT ECONOMIC DEVELOPMENT PROGRAM WHICH HE DIRECTED, THE HOUSTON POST SAID TODAY.

THE NEWSPAPER SAID IN A COPYRIGHTED STORY THAT BENJAMIN RERNANDEZ, WHO HEADED THE NATIONAL HISPANIC FINANCE COMMITTEE DURING THE 1972 PRESIDENTIAL CAMPAIGN, HAD USED HIS POSITION TO OBTAIN MONEY FOR A FIRM HE OWNED.

FERNANDEZ ORGANIZED THE NATIONAL ECONOMIC DEVELOPMENT ASSOCIATION

IN 1979 AND BECAME ITS CHAIRMAN AND PRESIDENT.

THE ORGANIZATION, WHICH RECEIVED A \$600,300 GRANT FROM THE SMALL BUSINESS ADMINISTRATION, WAS A NUMPROFIT MANAGEMENT CONSULTANT CORPORATION THAT COUNSELED MINORITY APPLICANTS FOR CHARTERS FOR BANKS AND BUILDING AND LOAM ASSOCIATIONS.

THE POST SAID FERNANDEZ TESTIFIED LAST NOVEMBER IN A CLOSED SESSION OF THE SENATE WATERGATE COMMITTEE THAT WHILE SERVING AS HEAD OF HEDA, HIS COMPANY, RESEARCH, INC., RECEIVED 10 FEES OF \$10,000 EACH FROM BANK APPLICANTS WHO HAD RECEIVED ASSISTANCE FROM NEDA.

FERNANDEZ TESTIFIED THAT WHILE HEAD OF NEDA HE DID NOT HOLD A POSITION IN RESEARCH, INC., WHICH OPERATED AT A LOSS, THE NEWSPAPER SAID. HE SAID HE SOLD THE FIRM AFTER BEING WITH NEDA SIX MONTHS.

THE POST SAID AN EXHIBIT IN THE COMMITTEE FILES CONTAINS A MEMO FROM NEDA EXECUTIVE VICE PRESIDENT ALFRED R. VILLALOBOS WHICH SAID:

"THE ALLEGATION THAT MR. FERNANDEZ USED HIS POSITION AT NEDA FOR HIS PERSONAL FINANCIAL BETTERMENT IS TRUE AND WHILE ILLEGALITY WOULD BE DIFFICULT TO PROVE, THERE IS NO DOUBT THAT CERTAIN OF HIS ACTIONS WERE IMPROPER."

DURING THE 1972 CAMPAIGN, THE NATIONAL HISPANIC FINANCE COMMITTEE, REPORTING DIRECTLY TO THE PRESIDENT'S CHIEF FUND RAISER, MAURICE STANS, RAISED ABOUT \$330,000 FOR THE CAMPAIGN, THE PUST SAID WATERGATE COMMITTEE FILES SHOW.
