I. PURPOSE

To commemorate the association of the 500th American city (Savannah, Georgia) with the Sister Cities program.

II. BACKGROUND, PARTICIPANTS & PRESS ARRANGEMENTS

A. Background: Sister Cities International is a private organization which sponsors the association of Americancities with appropriate foreign communities in approximately 70 countries, primarily in the Third World. The Department of State provides the organization with grant funds. These associations foster improved relations between the U.S. and the country concerned in a number of ways; American cities often provide assistance to the less developed associate cities and the daily people-to-people contacts permit an extremely broad range of cultural, social and economic exchanges.

In January, 1975, you accepted the honorary chairmanship of Sister Cities International. In addition, there is considerable support for the organization in Congress. Today's ceremony marks the association of Savannah with Patras, Greece.

B.
