

BACKGROUND

The New Coalition consists of 3 Governors, 3 Legislators, 3 Mayors and 3 County Officials along with the staff of the major public interest groups assisting in their major activities. During 1974 we held a number of consultation sessions with them relative to their concerns about the FY '76 Budget. It was their desire then as it is now, to institute a process of budget consultation so that they can be heard as the Federal Budget is put together. All are expected to attend unless otherwise noted.
