This memorandum reports upon the current status of vacancies and potential vacancies within the ranks of Federal Judges, U. S. Attorneys, and U. S. Marshals. The information presented is based upon Justice Department data and other pertinent materials at our disposal.

It should be noted that Attorney and Marshal vacancies are technical in character. To wit, a seat is rarely, if ever, physically vacant since (1) upon expiration of a term the incumbent continues to serve until a new or reappointment is made; or (2) upon the death or resignation of an incumbent, the court usually appoints an individual to serve until a Presidential appointment is made. Consequently, the existence of a vacancy does not suggest that the job is unattended as is the case with vacancies on a bench.

FEDERAL JUDGES

Within the U. S. and its Territories there are 523 Federal Judges all of which, with the exception of those seats in the Territories and the District of Columbia, are Life Appointments earning a Level II equivalent (\$42,000 per annum). Currently, 16 are vacant, and one other is in clearance at the White House. Consequently, there are 15 actual vacancies (.029%); and the following chart statistically reviews the entire Federal situation:

WEEKLY DOMESTIC REPORT FOR THE PRESIDENT

1. Emergency Housing Act of 1975 (HR 4485)

We have communicated to Carla Hills your decision to go with an expanded tandem plan. We are working with Carla and OMB on a tough but responsible veto message.

Max Friedersdorf and others recommend that the veto message be sent up on the afternoon of the last day you have to act on this bill, which is Tuesday, June 24.

2. Uranium Enrichment

We are proceeding with circulating a draft message to your senior staff on this issue. Our plan is to have a message for you to review this weekend, so that it would be ready to send to the Congress on Tuesday, June 24. Jim Connor, Bob Fri and I will be meeting informally next week with members of the Joint Committee on Atomic Energy to review our plans.

3. Highway Legislation

Jim Lynn and his top staff have met with Secretary Coleman to iron out remaining difficulties. We expect to resolve the issue of accelerated funding for Interstate substitution projects by internalizing the impact within the given State.

Draft legislation is almost ready. Draft message arrived today from DOT. We expect to be ready to go to the Congress next week.

5. Consumer Protection

Hearings are being held this week on HR 7575. We have worked to have eight Cabinet Secretaries called to testify on the impact the proposed Agency would have on their departments.

6. Judgeships

Sixteen vacancies at present.

7. Regulatory Reform

The meeting with the twenty members of the House and Senate will be on Wednesday, June 25. Rod Hills is working with the Domestic Council to prepare the papers for that meeting and the subsequent meeting with the members of the Regulatory Commissions.

8. Auto Emissions

Congress did not go through the extensive hearings we expected. Since Senate markup begins next week on auto emissions, it may be necessary for you to send a statement of your position to the Congress early next week. We will have a memorandum and recommendation to you on auto emissions on Friday, June 20.
