#### I. PURPOSE

To announce officially the calling of the White House Conference on Handicapped Individuals, the appointment of Dr. Henry Viscardi, Jr., as the Chairman of the Conference, and to affirm your support of the Conference.

# II. BACKGROUND, PARTICIPANTS & PRESS PLAN

# A. Background:

Last spring you decided to call a White House Conference on Handicapped Individuals, as authorized by P.L. 93-516 which you signed on December 7, 1974.

The purpose of the Conference is to:

- -- to stimulate a national assessment of problems faced by individuals with physical or mental handicaps;
- -- to generate a national awareness of those problems; and
- -- to develop recommendations for legislative and administrative actions to allow individuals with handicaps to live their lives independently, with dignity, and with integration into community life.

Many handicapped persons will participate in this conference. Handicapped persons are on the National Planning and Advisory Council, and the planning staff and will comprise at least half the delegates to the National Conference. Also, the handicapped will be encouraged to participate in the conferences that will be held in each state and territory next spring and summer before the National Conference.

The Chairman of the National Planning and Advisory Council and of the National Conference, Dr. Henry Viscardi, Jr., is handicapped. Dr. Viscardi has a distinguished career in the field of handicapped. He is a member of the President's Committee on Employment of the Handicapped and holds similar positions on the state and local levels. He is an assistant professor of clinical rehabilitation medicine at the New York University Medical Center and has written eight books on rehabilitation.

The Executive Director of the Conference, Jack Smith, who is also handicapped, was an Assistant Dean at the National Technical Institute for the Deaf, Rochester Institute of Technology.
