#### 1. PURPOSE

Host a reception for the Executive Committee and Finance Chairmen of the President Ford Committee.

#### II. BACKGROUND, PARTICIPANTS AND PRESS PLAN

A. Background: The Reception for the Executive Committee and Finance Chairmen of the President Ford Committee will follow a full day of meetings at which the PFC finance program for the next several months will be presented in great detail. Each chairman will be assigned his goals and provided with a plan to attain them.
