This meeting is being held in response to requests by Mayors in town for the Mid-Winter Meeting of the U.S. Conference of Mayors.

This is the first meeting of the U.S. Conference of Mayors since their annual meeting in July, 1975, in Boston. That Conference concluded with major victories for the Administration on General Revenue Sharing and Defense Spending Resolutions. You will recall that you invited the Mayors to come to the White House immediately after the Boston meeting where you addressed them in the East Room.

Given the reaction of the U.S. Conference of Mayors to your Budget (see Tab A), it should be expected that a number of Democrats will attempt to spearhead resolutions that will be critical of your Economic Report and Budget for the next fiscal year. Paul O'Neill and Steve McConahey will be caucusing with Republican Mayors tonight in an attempt to brief them and solidify a logical area of support for your programs.
