You will also sign a memorandum to heads of Departments and Agencies to call attention to the Civil Service Commission's program to provide summer jobs for needy youth.

- 1. I am pleased that a number of distinguished representatives of State, county and city governments are with us.
- 2. The Secretary of Labor, Bill Usery, and the Chairman of the Civil Service Commission, Bob Hampton, are also here.
- 3. We have all been encouraged by the steady improvement shown in the economy the last several months. The Secretary of Labor advises me that the youth employment situation has also shown signs of improving.
- 4. Nevertheless, with the advent of summer vacations, it is clear that more young people will be seeking jobs than the private sector will be able to provide.
- 5. I am, therefore, formally transmitting to the Congress today a request for an urgent supplemental to provide \$528 million to support jobs for 888,100 disadvantaged youth this summer.
- 6. If the Congress will act promptly on my request, local CETA sponsors will be able to provide meaningful work and training opportunities for substantial numbers of young people.
- 7. I am also sending a memorandum today to the heads of all Federal Departments and Agencies calling upon them to cooperate to the fullest with the efforts of the Civil Service Commission to provide summer jobs in government for an additional 54,000 needy youth.
- 8. Finally, on a related matter, I want to again urge Congress to act on my request of January for \$1.7 billion to continue the existing public service employment program. Many CETA local prime sponsors are running short of funds and will have to lay people off if Congress does not act soon.
- 9. Whatever differences of opinion may exist on the job creation issue, there is no reason why local officials and those already employed in CETA public jobs should be kept in suspense and in fear of lay offs.
- 10. I hope the Congress will act promptly on these important matters and I am now pleased to sign the two messages.
