I. PURPOSE

To meet with Governor Thomson regarding your recent signing of H.R. 13585, the Federal Boat Safety Act Amendments, and to provide a photo opportunity for publicity.

II. BACKGROUND, PARTICIPANTS AND PRESS PLAN

A. Background:

Governor Thomson has been deeply involved in the passage of H.R. 13585, the Federal Boat Safety Act Amendments, which (1) increases to 50% the maximum share of State boating safety programs, (2) limits to 5 years a manufacturer's duty to notify boat owners of safety defects, (3) suspends enforcement of the Federal boating laws on certain waters in New Hampshire until a court decision is reached and makes several other minor changes. He appealed to you and Secretary Coleman earlier on this issue and is delighted that you have approved it.

In particular, Governor Thomson urged your approval because of the suspension of enforcement of Federal boating laws. As a result of your action, certain waterways in New Hampshire, including Lake Winnisquam, Lake Winnipesaukee, portions of the Merrimack River, will not be subject to the jurisdiction of the United States Coast Guard until a final judicial decision is made. In the case of Lake Winnipesaukee, this bill would prohibit the Coast Guard from imposing its standards for a bridge now being proposed for the area.



Governor Thomson views this matter as one of the most important issues in his campaign and for your own campaign in New Hampshire. He views the bill as a symbol against unnecessary Federal intervention into state operations and has spoken extensively around the state about it.
