Enclosed is a letter and personal note to the President from Arthur Flemming, Chairman of the Civil Rights Commission and HEW Commissioner on Aging.

Since the President is beginning to meet with minority groups, I think it might be useful for him to visit with Dr. Flemming and his Commission. President Kennedy, who created the Commission, met with it on two or three occasions. Presidents Johnson and Nixon each met with the Commission on only one occasion in the early months of their Administrations.

From his work with the Hoover Commission and HEW, Flemming is also extremely well-versed in government organization. He has remarked on several occasions to me that he would welcome the opportunity to discuss with the President issues of White House organization and particularly the effective use of the Cabinet system.
