August 24th.

President's mail - August 24, 1974

House

Clair Burgener	Recommends that Dr. Robin W. Goodenough be appointed as a Public Member to the U. S. Delegation at the United Nations.
Wm Jennings Bryan Dorn	Recommends that R. I. Newman be appointed to the Atomic Energy Commission.
Joel T. Broyhill	Forwards copy of a resolution adopted by the Vienna (Virginia) Town Council; pledges support of the President.
John H. Ware	Suggests that the President create an amnesty board which would review the violations on an individual basis.
William Ketchum	Sends suggestions of a constituent about our economic situation.
George O'Brien	Says he thought the President would want to know that Gwen Anderson did a marvelous job in getting a substitute speaker in Jdlet when the President's schedule precluded his keeping the engagement.
Jack Kemp	Recommends that Thomas Hobart be appointed to the Nat'l White House Education Conference Committee.
Joel Pritchard	Says "the photo session was terrific."
Ella Grasso	Very warm letter -- "We all . . . stand tall again . . . it is good to see people smile again . . . This is a willing Congress again."
Edward Boland	Is opposed to the ten cents per gallon tax increase on gasoline; would be harsh impact on wage earners whose automobile is means of livelihood.
Thad Cochran	Sends article from the NATCHEZ DEMOCRAT in support of the President, which the Congressman feels reflects the sentiments of most Mississippians.
Joel Broyhill	Endorses invitation to the President to be the recipient of the International Sportsman Award to be presented at a banquet on Nov 20 at the Sheraton Park Hotel in Washington.

President's mail - August 24, 1974

House (continued)

Bill Frenzel

Feels that it is imperative that current negotiations with Israel be completed which will assure her ability to bargain as an equal and survive as a state; says that Israel feels that she is inadequately armed to repel an attack from Syria.

Lindy Boggs

Sends copy of letter from John Wayne in response to the letter that the President co-signed inviting him to the dinner for District Attorney Connick in New Orleans; Wayne expresses his regrets.

Bob Sikes

Expresses concern over the National Airlines strike; hopes that every possible action will be taken to bring about an end to the strike as soon as possible.

President's mail - August 24, 1974

Senate

Dewey Bartlett	Deeply concerned about reports that the President is considering a ten-cents per gallon tax increase on gasoline.
Warren Magnuson	Disturbed by reports that the Administration is considering decontrol of prices on about 75% of the nation's domestically produced crude oil; strongly urges that the President reject any recommendations to decontrol the price of old domestic oil, particularly at a time when world oil prices are at monopoly levels and the oil industry refuses to increase domestic production; believes that the nation's energy policies should be implemented to reflect a concern for consumers rather than a peculiar aberration in the fight against inflation.
Clifford Hansen	Thanks President for inviting him to accompany him to Chicago; appreciates the invitation to the White House when the President met with America's Junior Miss for 1974.
Strom Thurmond	Recommends that Joseph P. Rogers be appointed to the Military Court of Appeals.
William Scott	Recommends that Walter E. Warren be appointed to the Renegotiation Board.
Former Senator John J. Williams	Wishes the President every success; pledges support.
Bob Dole	Urges that, in setting priorities for food aid as between serving foreign policy objectives versus humanitarian assistance, the hungry, especially children, be given the first priority; says that the world food supply and price situation is multiplying the number of poor people suffering from hunger and malnutrition.
Robert Taft	Recommends that Norton R. Webster be appointed to the Board of Directors of the Legal Services Corporation.

Senate (continued)

Robert Taft

Recommends that Andrew G. White III be appointed to a position with the Department of Justice or LEAA.

James Pearson

Recommends that James A. McCain be appointed to an advisory position on the Council of Wage and Price Stability.

Robert Taft

Recommends that Dale D. Streid be appointed to a position on the White House staff.
