Attached is the log of Congressional mail to the President received yesterday, August 26.

President's mail - August 26, 1974

House

William Lehman	Says that South Florida is in great need of funds for water quality and sewer grant funds; hopes the President will end the present impoundment of EPA water and sewer grant funds.
Barry Goldwater, Jr.	As Chairman of the Republican Task Force on Privacy of the House of Representatives, sends copy of its initial Task Force Report and asks for the President's comments.
Olin Teague	Believes there would be merit in the establishment of a Council of Science Advisers, similar to the Council of Economic Advisers.
Joshua Eilberg	Asks the Department of State be required to effect the coordination, cooperation, and initiative which is necessary to determine whether or not the alleged Nazi war criminals in the U.S. are subject to denaturalization, extradition, or deportation.
Bill Archer	Requests an autographed photograph for Sultan Ahmed.
Wm Ketchum and Robert Lagomarsino	Hopes that the President will support their health insurance plan. They introduced H.R. 16532 on August 21, which is based upon the phenomenal success of the program now existing in British Columbia.
Elizabeth Holtzman	Appreciates being invited to the ceremony for the signing of the Women's Equality Day proclamation.
Donald Brotzman	Invites the President to join him on September 21 when the University of Colorado will be hosted in a football game by the University of Michigan at Ann Arbor.
Don Young	Recommends that Wendell Wyatt be appointed as Commissioner of the U.S. Section of the International North Pacific Fisheries Commission.

Garner Shriver	Requests the President's assistance in making available a member of the Council of Economic Advisors to make the opening address at the Grassroots Summit on the Economy in his Congressional District on September 14.
Matthew J. Rinaldo	Recommends that Gabriel Malkin be appointed to the President's Air Quality Advisory Board.
Mike McCormack	Recommends that George Gleason be appointed to the Atomic Energy Commission.
Dante Fascell	Recommends that Robert V. Walker be appointed as a participant in the Economic Summit Meeting.
John J. Rhodes	Recommends that Michael W. Blommer be appointed to a position at the White House.
Lindy Boggs	Recommends that Victor Labat be appointed to the White House staff in the area of minority affairs.
John J. Rhodes	Conveys the desire of Ab Sibal to serve the Administration in an appropriate position.
John J. Rhodes	Recommends that Isabel A. Burgess be appointed to another term on the National Transportation Safety Board.
John J. Rhodes	Encloses resume of Alan Douglas Ewen who is interested in working in the Administration for a couple of years.
Roger Zion	If the President is able to keep the October 16 commitment in Indianapolis, hopes that he will take a helicopter to the Grisson Airport and make a brief appearance there in behalf of the Congressman.

Robert McClory	Encloses three Christmas Cards which he requests that the President autograph.
Wm Broomfield	Endorses invitation to the President to attend the dedication ceremony of the National Association of Homebuilders' new building on October 16.
Matthew Rinaldo	Recommends that Orlando D. Martino be appointed to the position of Associate Director of International Operations at ACTION.
Paul Findley	Recommends that Arthur J. Falls be appointed to a position on the White House staff.
Ben Blackburn	Says that the President's assumption of the Presidency has brought a considerable boost to the morale of partisan loyalists about the country; hopes that the President's statement on amnesty, his announcement on his support for repeal of the Byrd Amendment on Rhodesian Chrome, along with the selection of Governor Rockefeller do not, in combination, represent a leftward drift in the President's philosophy.
Robert Bauman	Is gravely concerned with the President's positions on the issues of amnesty, Rhodesian chrome and the failure to veto H.R. 69, so that an iron clad anti-busing provision could have been included. Gov Rockefeller's nomination "is very hard for me to swallow."
Robert Bauman	Requests that the President restate the White House policy that no transfer of the Army Ordnance Center and School located at Aberdeen Proving Ground will occur at this time; requests a meeting with the President to discuss the matter.
James Quillen	Forwards letter addressed to the President from the Reverend Edward D. Johnson, together with a copy of one of his sermons.

Recommends that Ben A. Wallis, Jr. be appointed to an appropriate position in the Administration.

Paul Rogers

Concerned about the increasing drug traffic in Florida; urges that the President make recommendations to the Dept of State regarding initiating an agreement or treaty with the Carribean nations about the illicit drug traffic.

Fred Rooney

Encloses letter from the Librarian of the Lehigh University Linderman Library requesting a letter bearing the President's signature to include in its collection.

John Myers

Sends a copy of the New Testament which Bill and Tom Overpeck wanted the President to have.

Susan Green

Is interested in a position on the White House staff in the press office.

Senate


Robert Taft	Recommends that Benjamin F. Marsh be appointed to a position with the Administration.
James Eastland	Endorses Senator Hruska's recommendation that Kenneth Lazarus be appointed as Deputy White House Counsel.
Wm Roth	Urges that the President appoint representatives of business, labor, agriculture and consumer interests to serve on the Cost of Living Task Force.
Bob Dole	Urges the President to support his substitute bill to create a Consumer Advocacy Agency; says that it is similar in concept to a measure which passed the House in 1972 with the President's endorsement.
Wm Roth Edmund Muskie Sam Ervin <i>Bucher</i> <i>Musky</i>	Would appreciate the President's support of S. 2432, the Congressional Right to Information Act, which has passed the Senate and is pending in the House. Feel that early passage of the Congressional Right to Information Act could contribute to a healthy, long-term "marriage" between the President and the Congress.
Herman Talmadge	Forwards Form 171 on Maurice Dykes who is interest in securing a position with the White House.
Claiborne Pell	Recommends that Brackley Shaw be appointed to a position at the White House or in one of the Departments or Agencies.
