David Gartner AA to Humphrey	In absence of the Senator, who is in the People's Republic of China on a special Congressional mission, urges that a disaster declaration be declared in Minnesota due to the severe frost.
Robert Taft, Jr.	Recommends that Frank A. Nemecek be included as a member of the Economic Summit Meeting.
Philip A. Hart	Considers it good news that the President is considering amnesty and forwards a proposed amnesty plan.
J. Bennett Johnston	Forwards letter on behalf of the Disabled American Veterans representing servicemen in the Shreveport-Bossier, Louisiana area.
Strom Thurmond	Endorses invitation extended to the President to be guest at the second annual meeting of the Carolinas Hospital Public Relations Society being held October 16-18 in Charleston, S. C.
Peter H. Dominick	Endorses Dr. Howard D. Greyber for a position on the White House staff or the National Security Council.
Robert Taft, Jr.	Recommends Ralph B. Kohnen, Jr. for appointment to a Presidential board or commission.
Jacob K. Javits	Recommends Seymour J. Rubin as a possible aid to Phillip Buchen.


