Sam Nunn Recommends that Bettye H. Kehrer be appointed

to the Board of Directors of the Legal Services

Corporation.

Robert Taft Invites the President to address the dedication

ceremonies of the New Medical Sciences Building at the University of Cincinnati on October 11. Secretary Weinberger will also be a speaker

for the occasion.

Robert Taft Invites the President to attend the Ohio State-

Michigan game to be played in Columbus on

November 23.

Strom Thurmond Recommends that the position of Director,

Herman Talmadge

Thanks President for the invitations to attend the Conference in Atlanta on September 12 and the Summit Conference on September 27 and 28; he will be out of town and cannot attend the ones in Washington.

Thomas J. McIntyre Norris Cotton Joins the President of Waterville Valley, one of New Hampshire's principal ski areas, in extending and invitation to President Ford. Feel that the President's presence at a ski area would mean so much to this industry which is of great importance to the economy of the New England area.

Herman Badillo

Thanks President for meeting with the Spanish-speaking Members of Congress; reiterates his deep concern over the manner in which the Department of Labor is implementing the Comprehensive Employment and Training Act's provisions relating to the limited English-speaking; that the Labor Dept's CEA regulations fail to reflect the Congress' intention that persons of limited English-speaking ability are to be given special consideration at all levels and in all programs.

Mark Andrews

Recommends that Ralph J. Erickstad be appointed to the Board of Directors of the Legal Services Corporation.

Asks that consideration be given to the suggestion of Charles Schamblin that interest on savings account be made tax exempt in an effort to encourage savings and slow down inflation.

Peter Peyser

Was shocked by the President's decision to pardon former President Nixon; says he is going to introduce a sense of the Congress resolution tomorrow expressing Congress' opposition to granting further pardons to Watergate "criminals."

Paul McCloskey

Feels that the pardon of former President Nixon prior to completion of the work of the courts was a serious mistake; feels that to pardon President Nixon and then to turn over to him the Watergate tapes without full public scrutiny cannot help but enhance present public suspicion that the Ford Administration has joined in the "coverup." Suggests that all such tapes and related documents be forwarded to the appropriate Congressional Committees for examination.
