SUBJECT: Campaign Advisor for Paul Goebel

During your talk on Tuesday with Paul Goebel, Jr., the Republican Congressional candidate from Grand Rapids, you suggested that some experienced incumbent might go into the district, look over the situation, and in effect serve as a special consultant to the campaign organization. In particular, you suggested that one of the retiring Members of the House might undertake this job.

I've attached a list of all the Republican House Members who are retiring this year (excluding those defeated in primaries or seeking other offices). The name of Chuck Chamberlain stands out as one obvious possibility.

I will follow through on this in any way you direct.
