Hopes the President will give favorable consideration to request in enclosed letter from Antone Hayden, Publisher of the Journal Newspaper Group, that the President conduct a rap session at the White House for all the Black Newspaper Publishers and Presidents. The Congressman would be "glad to sit in with you!"

Believe that the recent testimony of the Commissioner of the Immigration and Naturalization Service should be considered by the President and staff during the upcoming summit conference on the economy of this country; on basis of the committee's hearings and the Commissioner's testimony, believe that between 500,000 and 1 million jobs could be opened up and offer several suggestions on ways that it could be accomplished.

Bill Alexander

Asks that the President give thoughtful consideration to adding to the agenda of the Economic Summit conference the subject of the \$60 billion foreign debt owed to the U. S.; outlines several courses of action that he requests the Conference address itself to.

Charles Bennett

Informs the President who he has invited to attend the Summit Conference on Inflation.

Marvin Esch

Says that if we are to hold down increasing costs of automobiles, unwanted and unpopular devices (like the safety belt-ignition interlock system) should be removed; in view of the House action to make the interlock system optional, there is growing support to rescind these controls, and the Congressman requests the President's support in these efforts.

Bob Mathias

Sends copy of his letter from Mrs. Jewell Dye who is opposed to the pardon for former President Nixon.

Donald Brotzman

Encloses copy of his letter from Brigitta Pueschell who is opposed to the pardon for former President Nixon.

Charles Rangel	Welcomed the President's amnesty announcement; urges, however that it be extended to those who served in the Vietnam conflict and were released with less-than-honorable discharges.
Jack Brinkley	Supports the invitation extended to the President to be the special guest speaker at their annual Freedom Week ceremonies in Feb of 1975.
Jonathan B. Bingham	Asks for the President's assistance in behalf of Edward N. Evans, who has for 27 years tried to establish that the left hemiplegia from which he suffers is a service connected disability.
L.H. Fountain	Asks that the President give careful consideration to the enclosed communications from persons who have written to express concern for the welfare of our nation due to the serious problems facing the housing industry.
Bob Sikes	Asks that consideration be given to enclosed suggestion from Daniel Groves regarding the housing industry .
John Buchanan	Supports invitation to the President to speak at the banquet on November 8 at Samford University.
Burt L. Talcott	Recommends that William Knecht be appointed to the Nat'l Legal Services Corporation Board of Directors.
Joel T. Broyhill	Recommends that Harry Donohue be appointed as Associate Deputy Administrator of the VA.
John Wydler	Asks that consideration be given to Mr. John Kearse's request for a meeting with the President and knowledgeable people to discuss the future of the Community Action Program.

Richard White

Suggests that the President meet with President Echeverria at the historic Paso del Norte Hotel in El Paso; also suggests that a topic of discussion be the disruptive impasse on modes of public mass transportation between El Paso and Juarez.

Walter Kennedy
Minority Sgt at Arms

Admires the President for making a decision and implementing it without hesitation; shares with the President a letter that he received from Father Regis O'Brien, T.O.R., St. Francis College, Loretto, Penna., in support of the President.

Senate

Strom Thurmond	Supports invitation to the President from Mr. and Mrs. Jimmy Nash to be their dinner guest while in Anderson, S. C., on Oct 19.
Ernest Hollings	Hopes the President will be able to accept the invitation extended to him to attend the S.C. Municipal Association meeting in May, 1975.
Jim Buckley	Hopes the President will favorably consider the request of the Ex Dir of the Nat'l Right to Life Comte for the officers of that organization to meet with the President regarding the aspects of the pro-life movement.
Wm Scott	Recommends that Harry J. Donohue be appointed to a higher position in the VA.
Jacob Javits	In preparation for the forthcoming meeting with President Echeverria, hopes the President will put illicit drugs high on the agenda; concerned about reports that Mexico has replaced Turkey as the main illegal source of heroin; asks to be kept advised of the results of the meeting with respect to this subject.
Sam Nunn	Accepts invitation to attend the Summit Conference on Inflation; he will support a strong, bipartisan nat'l effort to provide continued, effective action on inflation.
Carl Curtis	Encloses copy of telegram from his constituent who expresses approval of the President's decision to pardon the former President.
John Sparkman	Asks for an autographed picture of the President.
Dick Clark	Recommends that Gerard Noonan be appointed to the amnesty review board.

Barry Goldwater

Concerned about the situation involving Pan American Airlines; believes we should charge every foreign country exactly what we are charged to land our planes at their airports; points out that we are charged from \$1,000 to \$5,000 in other countries and we charge those same countries a maximum of \$250 for landing at our int'l airports. Our companies purchase gas at exorbitant prices overseas, while foreign airplanes purchase gas at our very favorable prices. "Let's stop these discrepancies."
