SUBJECT: Consultants

Tab A lists consultants carried on the rolls paid at a daily rate. It is appropriate to advise several of these consultants that their consultancies are terminated. The deletions might include:

- William Carruthers
- John Eisenhower
- Charles Wilkinson
- Loie Gaunt
- Clay T. Whitehead

The first four on the above list were consultants for President Nixon. They are paid only when actually working and have not been called upon since I have been Staff Secretary.

Tab B includes consultants who are not officially carried on the rolls as consultants. They are "consultants" and effect their service by agreement. Again, these were brought on board during the Nixon Administration. None have been used since August 9th. All of these names should probably be removed from the consultancy list.

RECOMMENDATION

That the following names be deleted as consultants (Tab A): Carruthers, Eisenhower, Wilkinson, Gaunt, and Whitehead.

For the time being do not, repeat do not, delete Eisenhower or Wilkenson. Please get up a memo explaining their status, how much time they've worked in the past and what subjects they have worked on. Do not contact them at this time but just get a feel for what they have done in the past.
