SUBJECT: Telephone Calls

Upon reflection and discussion with Timmons, it seems to me that any telephone calls prior to definitive election returns are purely discretionary.

On Election Day or evening, phone calls should be placed to the Republican leadership (Scott, Brock, Rhodes, Michel) most involved in the election. On Tuesday evening Bill Timmons and I will both be making recommendations for congratulatory (or otherwise) telephone calls. We will also recommend telegrams to be dispatched on Wednesday.

I am attaching a memo from Timmons in which he suggests a list of challengers and incumbents for your consideration if you decide to make telephone calls prior to the election results.
