

Dear Paul:

This is in further reference to our earlier exchange of letters about a national health plan which President Ford could recommend and which could be passed by the Congress during the next two years.

It is my opinion that the complex and confusing "mandated" plan proposed by the Nixon Administration will not be acceptable to the new Congress. Moreover, I suggest that President Ford should recommend his own plan which should be formulated to obtain a wider base of support.

The approach which seems to have the widest support in Congress is the so-called "catastrophic" coverage type plan introduced by Senators Scott and Percy (S.2756) and Senators Long and Ribicoff (S.2513) with Representative Waggonner (H.R.14079). (The Scott-Percy bill includes a supplementary medical care plan on a voluntary basis.)

One variation would be to combine a catastrophic proposal with another type of popular coverage such as complete protection for all children under age 6. The cost of such a total package could be split three ways: one third by the employer, one third by the employee, and one third from general revenues. No member of Congress has yet introduced a bill which includes both catastrophic and childrens' coverage. The President could develop his own proposal by combining these various proposals which might well be supported by Chairman Mills, Chairman Long, Scott, Percy, and Ribicoff and thus assure the kind of cooperative bipartisan development of legislation.

A different possibility is to utilize the voluntary approach now in Part B of Medicare which provides that the Government pays one-half of the cost of all physicians coverage.

There are several possible combinations and variations of these general proposals, none of which in any combined form have been yet seriously considered in Congress. A new approach to national health insurance may be a startling and acceptable way for the President to break the log-jam on this important legislative matter.
