1. Mark Hannaford

Expresses opposition to an executive order being issued to open the Los Alamitos, California, Naval Air Station to general aviation purposes, and urges that this expansion not be allowed.

2. Jim Weaver

Writes on behalf of students from Ashland Senior High School Learning Center who would like to arrange for a cruise on a Navy ship in California. (The students visit Mexico each year to help the Miracle Ranch Orphanage.)

3. Bill Archer

Requests telegram of congratulations to Frank E. Mann, who has served in many public positions in Houston, to be read at his Appreciation Dinner.

4. Albert Johnson

Jack + Miles

Requests the President to make a television endorsement for him to be used in the Pennsylvania Primary on April 27. "Normally, I would not ask another Republican office-holder to help me in a primary election, but when my support of your vetoes becomes a major issue in the campaign, I think such a request is not inappropriate." Says he has asked Senators Scott and Schweiker, the State Chairman, and the Pennsylvania President Ford Committee Chairman to send the President a joint telegram endorsing this request. Says his office will supply suggested scripts or other assistance.

5. Albert Quie

Endorses invitation to attend the Minnesota Bicentennial Freedom Fest on June 26 in Minneapolis.

 Margaret Heckler Ronald Sarasin Jack Kemp Write about Lebanon's role as a stabilizing influence in the Middle East being jeopardized as a result of internal conflict. Note that Maronite Bishop Francis Zayek and Mr. Monsour Ferris, National Chairman of the Americans to Save Lebanon, have investigated the situation and possible solutions and would like to meet with the President and appropriate advisers. Recall that they met with Milt Mitler last Fall.

7. James Abdnor

Encloses detailed letter he received from Bob Duxbury, South Dakota's Secretary of Agriculture, in regard to the effects of increased palm oil imports on the domestic soybean producers.

8. James Abdnor

Writes in detail about the Meat Import Act and the effect the excess of meat imported ("not only above the levels voluntarily negotiated but above the statutory 'trigger point' as well") has on a market oriented agriculture policy. 'Negotiated import levels for the coming year must allow for a sufficient margin to ensure that the trigger point is not exceeded. Furthermore, it is only just that those nations which exceeded the levels negotiated in good faith, and thereby were responsible for the trigger point being breached, ought to be penalized a like amount to their overages in import levels negotiated for this year." Adds a handwritten p.s. saying that he feels the same kind of action taken on specialty steel imports should be taken on behalf of the cattle industry.

9. James Blanchard

Writes on behalf of veterans organizations in Michigan requesting that the President intercede with the V.A. in order to bring about the construction of a new V.A. Hospital in the Detroit area.

10. Peter Peyser

Says he realizes the need to hold down the Budget, but also believes the 50 million dollars for the 1980 International Winter Olympics Games could be easily obtained "by adjusting what your own Agriculture Department feels is the outrageous subsidy being paid this year, and over the next four years, to the peanut farmers." Says the amount saved would be 804 million dollars over the next five years.

11. William Wampler

Encloses letter he sent to the Secretary of HEW urging a waiver of the proposed Health Service Area for Southwest Virginia to allow it to include several adjacent areas. Says this is supported by the Governors of Virginia and Tennessee and others, and that the situation is similar to the one in Pennsylvania which prompted such a waiver for that State.

12. William Ketchum

Recommends Robert C. Kramer for the Board for International Food and Agriculture Development.

13. Phil Landrum

Recommends Gary L. Curran for Alternate Federal Cochairman of the Appalachian Regional Commission.

- 14. Tom Bevill Recommends Gary L. Curran for Alternate Federal Cochairman of the Appalachian Regional Commission.
- 15. Alan Steelman Recommends Charles Luna for reappointment to the Board of Amtrak.
- 16. Thad Cochran Recommends Irby Turner, Jr., for the Board of Directors of the Corporation for Public Broadcasting.
- 17. L. H. Fountain Endorses invitation to address the National Association of Plumbing, Heating, and Cooling Contractors convention at the Sheraton Park Hotel June 19-23.
- 18. Larry Pressler Endorses invitation to address the Distributive Education Clubs Career Development Conference in May in Chicago.
- 19. 17 Members Send detailed letter urging that "immediate steps be taken to program at least one million tons of rice under P.L. 480 and arrange to have it shipped prior to the new rice crop in August." Point out that a commitment of 850,000 tons was established for fiscal 1976, but that only 385,000 tons have been programmed. Believe the commitment is in serious jeopardy of not being fulfilled due to "bureaucratic inaction." Note that "the latest purchase of rice under P.L. 480 by Bangladesh took place last week after a lapse of almost five months and went at prices over \$100 per metric ton, or about 40% lower than the previous purchase in October, 1975. The price collapse is due to the programming delay and the widespread conviction that the 850,000 ton commitment will not be fulfilled in time." Request a meeting with the President and top advisers to discuss the matter.
