Senate

1. S Hubert Humphrey Urges the President to call the White House Conference on Library and Information Services as soon as possible.
2. S Richard Stone Supports invitation to the President to be commencement speaker at the Jacksonville University either in 1975 or 1976.
3. S Hiram Fong Recommends that D. Hebden Porteus be appointed as the Representative of the U. S. on the South Pacific Commission.
4. S Robert Taft Conveys the interest of William Frank in being appointed to an appropriate position at EPA.
5. S James B. Pearson Recommends that Francis H. Heller be appointed to the Truman Memorial Scholarship Foundation.
6. S Gale McGee Again recommends that Abbott Washburn be appointed to the FCC.
7. S Bill Brock Urges the President to sign the Emergency Farm Bill; says that the Tennessee farmers have been the victims of numerous natural disasters in the past three years which have hurt them economically. Thus, he cannot support a veto, and hopes the President will consider an alternative to that choice. On a more general note, expresses strong desire to be helpful in any way that he can.
8. S Carl Curtis Recommends that Andrew Rodriguez, Jr. be awarded posthumously a Presidential Medal of Freedom for an act of heroism that cost him his life.
9. S Stuart Symington Recommends that W. Sterling Cole be appointed to an ambassadorship.
10. S Clifford Hansen Extends an invitation to the President on behalf of the University of Wyoming to be keynote speaker at the Summer Commencement Exercises July 30 or August 6.

House

1. Joseph L. Fisher Outlines several issues regarding the operation of the National and Dulles International airports which are awaiting action at the FAA. "I would urge that your appointment of an Administrator of FAA be based in part on policy decisions by you on these questions. Some of these may seem to be issues of local interest, but as they are under the control of a Presidentially appointed administrator, I feel that they should be brought to your attention."
2. Robin Beard Encloses copy of his bill H.R. 6056, regarding gun controls, and hopes the President will see fit to support it.
3. G. Wm Whitehurst Urges the President to issue the call for the White House Conference on Library and Information Services as soon as possible.
4. Elford A. Cederberg Recommends that Hessel E. Yntema, Jr., be appointed to a position dealing with the Vietnam area.
5. Bill Frenzel Recommends that David Lilly be appointed to the Federal Reserve Board.
6. Ed Young Says that there is a strong feeling in his area that the President needs to develop more Southern strategy. Suggests that one of his appointments to the Cabinet be someone from the South.
7. Tom Steed Conveys the interest of Congressman James Jones in participating in the forthcoming meeting with regulatory agency commissioners. Hopes that he will be given every consideration.
8. James R. Jones Commends the President on his decision to call together commissioners of the ten major independent regulatory agencies and representatives of the Congress for the purpose of reducing the inflationary impact of federal regulatory policies and decisions on our economy; would deeply appreciate the opportunity to participate in the meetings.

9. The Speaker Acknowledges receipt of the President's April 25 letter transmitting a draft bill "To extend and revise the State and Local Fiscal Assistance Act of 1972. "
10. The Speaker Commends the President for decision to call Commissioners of the Independent Regulatory Agencies and Representatives from Congress to a meeting at the White House; supports Congressman James R. Jones' interest in participating.
11. Carl D. Perkins Encloses copy of his bill H. R. 1358, regarding a commercial scale liquefaction and gasification industry; expresses concern about UPI article saying that Coal Week Magazine is reporting that the Energy Task Force may recommend that the number of synethetic fuel plants proposed for Project Independence be cut from 20 to 5. Urges that all 20 be built.
12. Robert Michel Sends copy of letter he received from the President of the Commercial National Bank of Peoria commending Secretary Butz regarding his recent appearance in Central Illinois.
13. Guy Vander Jagt Recommends that Dave Gezon be appointed to the Public Advisory Committee to the U. S. Special Trade Representative.
14. Trent Lott Recommends that Lee R. Spence be appointed to the Federal Home Loan Bank Board.
15. William Walsh Recommends that Monsignor Charles J. Fahey be appointed to the Federal Council on Aging.

16. Mario Biaggi Hopes the President will be able to accept the invitation to a special reception for Congressmen of Italian descent to be held Tuesday, May 6, in the Cannon Caucus Room from 6:30 to 8:30 p. m.

17. Jack Edwards "As one who has twice voted for the Strip Mining Bill, I want you to know that I will vote to sustain a veto of that Bill. In fact, I urge a veto if it appears sustainable. "
