1. S    Howard Baker                    Endorses invitation from the Board of Directors and the membership of the Printing Industry Association of the South for the President to speak at their annual convention to be held in Nashville on Sept 25-27, 1975.
  
2. S    Barry Goldwater                    In view of the obvious importance of our ongoing negotiations with 140 nations regarding the Law of the Sea, recommends that Deputy Special Representative, John Norton Moore, be raised to the position of Special Representative for the President.
  
3. S    Dewey Bartlett                    Feels that regulations promulgated by HEW with respect to day care centers are intolerable; under these regulations, which are scheduled to go into effect in October, the cost increase to the mother has been estimated to be from 50 to 400 percent. Hopes the President will amend them to "reflect not only Congressional intent, but common sense."
  
4. S    John Tower                        Supports invitation to the President to address the annual convention of the Texas Cattle Feeders Association on Oct 20 or 21.
  
5. S    Robert Griffin                    Hopes the President and Mrs. Ford will be able to accept invitation to attend a bicentennial event in the Village of Oxford, Michigan, sometime during the first six months of 1976.
  
6. S    Strom Thurmond                    Supports the invitation from the South Carolina Broadcasters Association for the President to be the banquet speaker at its Winter Convention Feb 12-14, 1976.
  
7. S    Robert Stafford  
      Patrick Leahy                    Express concern over the potential ramifications in Vermont of the possible expiration of the mandatory allocation section of the Emergency Petroleum Act of 1973. An analysis of the gas shortage in Vermont during the 1973-74 crisis indicated it was not entirely due to the embargo, but was in part caused by some major oil companies pulling out and concentrating on high volume outlets.

- 8.S Jesse Helms Encloses petitions from his constituents who are disappointed over the inability of the President and Mr. Solzhenitsyn to get together during his recent visit here.
- 9.S Office of Senator Domenici  In behalf of a constituent, asks whether Steve Ford's middle name is a family name.
- 10.S Floyd Haskell Is delighted that the President will visit the Paraho Retort Oil Shale Plant near Rifle, Colorado; hopes he also will have time to inspect the In-Situ Pilot Project of Occidental Oil; appreciates the President's interest in the need for proper development of our oil shale resources.
- 11.S Congressional Summer Interns To date, 48 Congressional interns have written to the President thanking him for the invitation to the White House and apologizing for the disrespectful behavior of the few.
