- 2. Richard Vander Veen "I have taken time this afternoon to thank God that you did not fall victim to the crazy act of an unbalanced person." Feels that we should take steps to remove the guns that give lethal power to people with mixed up minds or criminal intent.
- 3. Albert Quie Forwards materials which he has received from Gilman Hill, who has a technologically and economically feasible process to extract oil from shale. The Congressman believes the proposal should be explored at the highest levels in our Gov't.
- 4. Helen Meyner Is anxious to have the proposed Armament Development Center located in New Jersey; understands that the decision is to be made shortly on the location.
- 5. James Abdnor Says that retailers of propane gas in South Dakota which are supplied ultimately by McCulloch Gas Processing Corporation have received letters from Eastern Petroleum Company stating that "... due to the fact that all controls on natural gas liquids will Frank Jul no longer exist after Aug 31, 1975, we no longer have any definite contract commitments to us, and therefore, we are notifying each of the dealers that have filed their Form 17 with us, that it is a great possibility we may not be able to be of assistance to you whatsoever. . . suggest that you protect yourselves anyway you can. . . " Feels that this is the type of action that makes it difficult to accept the idea that the major businesses will deal responsibly with deregulation and urges an immediate investigation of this firm's activities.
