Oct. 3 Called Mrs. Richard Ford. She said there is a Kent Burba and she will check further with Ted to get his background, etc.

Called Mrs. Ford back. She checked with Linda who checked with Ted who also checked with his mother. Kent Burba is considered the "black sheep" of the family and has a jail record. Ted and his mother and the GR Fords would not recommend he get involved in PFC. Kent Burba may be an uncle of Ted Burba.
