Question

Mr. President: Governor Thomson (R-New Hampshire) stated that he would withhold his support of you pending the campaign and until he sees how the issues develop in the campaign. What do you see as some of the major issues in New Hampshire?

Answer

While I have not heard that statement by Governor Thomson, I am convinced that two of the major issues of concern to the voters of New Hampshire are <u>fiscal</u> responsibility in government and the development of solutions to our energy problems.

I know that New Hampshire has no sales tax and no State income tax and that your State expects to achieve a surplus this year and projects surpluses for future years. This is commendable and is the kind of fiscal responsibility I am sure New Hampshire voters want from Presidential candidates. On the energy question the citizens of New Hampshire have been concerned about, the lack of alternatives to foreign imports and many in New Hampshire share with us a goal of developing as soon as possible and in a reasonable and responsible way the resources of the Outer Continental Shelf as well as our nuclear power generating capability.

My recommendations on this are clear and I think there is broad support in New Hampshire for the goals I have stated on numerous occasions.
