My good friend, Catherine May Bedell, called me this afternoon to give me the following information, which she thought the President might like to have.

Mrs. Reid's son, Tom, was in a very terrible automobile accident in mid-October and is paralyzed from the neck down. Surgery was done, but apparently nothing can be done for him.

Catherine said Mrs. Reid is taking this very hard and having difficulty reconciling herself to this tragedy.

Tom is presently in the Veterans Administration Hospital in Long Beach, California, Building 122, Ward C-1. His full name is Edward T. Reid.

If it would be helpful, Mrs. Reid's office number is 632-7007. Her home number is 525-6335.

I told Catherine I would pass this information along to you promptly.
