The following is a current status report on personnel changes at the Federal Reserve Board:

- (1) J. Charles Partee has been confirmed to fill the vacancy created when Jeffrey M. Buchen resigned. I understand Chairman Burns expects to swear him in on January 5;
- (2) You have approved the nomination of Stephen S. Gardner to replace George W. Mitchell as Vice Chairman of the Board of Governors when Mitchell's term expires January 31, 1976.

With the approval of Chairman Burns and Secretary Simon, the Gardner nomination will be held until early January 1976 so that Secretary Simon has the maximum time possible to complete his reorganization plans.
