This memorandum seeks your approval of the appointment of Ralph Guy, Jr. as U.S. District Judge for the Eastern District of Michigan. A career profile is attached for your review (Tab A).

Ralph Guy, Jr., 46, a Republican, currently is the U.S. Attorney for the Eastern District of Michigan. Prior to that appointment, he was an Assistant U.S. Attorney. He has served as Assistant Corporation Counsel and Corporation Counsel of the City of Dearborn, Michigan and was in private practice in Dearborn.

A graduate of the University of Michigan where he also received his LL. B., Mr. Guy resides in Dearborn, Michigan. He is represented by Congressman John Dingell (D).

Attorney General Levi recommends this appointment, and I concur.
