The Committee, after thorough consideration has voted to disclose this figure. This decision was made after first hearing the views of CIA Director George Bush, as well as many high officials including four former Directors of the Central Intelligence Agency. I can report that the Committee's decision was based upon a careful review of the security aspects of the issue. It was a matter that was reviewed and debated many times over the past fifteen months.

The overwhelming evidence makes clear that disclosure of the aggregate budget figure for national intelligence would not adversely affect United States security, but would, in fact, serve to strengthen adherence to constitutional government by complying with the obligation imposed by the Constitution in Article I, Section 9, Clause 7 that:

> No Money shall be drawn from the Treasury, but in Consequence of Appropriations made by Law; and a regular Statement and Account of the Receipts and Expenditures of all public Money shall be published from time to time.

Despite the fact that the Committee has already voted to release this aggregate budget figure, I will, nonetheless, convene the Committee as you requested on Monday, April 26, to hear Mr. Bush's views before a final decision is made.
