There are presently ten vacancies on the National Council for the Humanities. The Council is composed of the Chairman and twenty-six other members from private life appointed by the President to serve a six year term and the members are paid when actually employed. The Council advises the Chairman with respect to policy and reviews funding applications. (Legis., Tab A)

Chairman Berman and I recommend the following candidates:

John Paul Austin, 61, a Republican from the Fifth Congressional District of Georgia represented by Congressman Young. (Resume, Tab B) Austin is the Chairman of the Board and Chief Executive Officer of the Coca-Cola Company in Atlanta, Georgia. He began his career as an attorney and has risen steadily to achieve the rank as one of the foremost business leaders in the country. Mr. Austin is a member of the National Industrial Advisory Council of Opportunities. Industrial Center and chairman of the Atlanta OIC Advisory Board. He is a member of the Board of Regents of the Smithsonian Institution, a member of the Board of the Twentieth Century Fund and a member of the California Institute of Technology Board of Trustees.

Nancy Davies, 48, a Republican from the Sixth Congressional District of Oklahoma represented by Congressman English. (Resume, Tab C) Ms. Davies was the first woman President of the University of Oklahoma Board of Regents (1968-1973) and is currently a member of the Oklahoma Humanities Committee. She is strongly supported by Senator Bellmon and is respected as a friend of education in Oklahoma. She would bring to the council an ability to speak for both the public sector and the currently under-represented State of Oklahoma. Davies has been active and effective in state and local Republican politics.

John Hope Franklin, 61, a Democrat from the First Congressional District of Illinois represented by Congressman Metcalfe. (Resume, Tab D) Franklin is the John Matthews Manly Professor of History at the University of Chicago and is generally recognized as the country's most outstanding Black historian. Franklin received his Ph.D. from Harvard and has taught and lectured at a wide number of colleges and universities. He aided the NAACP in their preparation of the brief which eventually led to the historic civil rights decision of the Supreme Court in 1954. Franklin's broad historical perspective and the breadth of his interests eminently qualify him for the council. His extensive experience teaching at Black colleges and scholarly approach to a new field would fill two serious gaps on the council.

Jay Gordon Hall, 65, a Republican from the Nineteenth Congressional District of Michigan represented by Congressman Broomfield. (Resume, Tab E) Hall is currently Director of Government Relations for the General Motors Corporation. Dr. Hall is an accomplished Latin scholar whose specialty is the Roman statesman and author Cicero. He also maintains one of the largest private libraries in America.

James Willard Hurst, 65, a Democrat from the Second Congressional District of Wisconsin represented by Congressman Kastenmeier. Hurst is a distinguished legal scholar and professor of law at the University of Wisconsin. Though a Democrat, his reputation is such that he must be considered above partisan politics. He is a distinguished jurist and founded the Madison Circle School of Jurisprudence. (Resume, Tab F)

Concha Ortiz y Pino de Kleven, 61, a Democrat from the First
Congressional District of New Mexico represented by Congressman
Lujan. (Resume, Tab G) Mrs. de Kleven is a distinguished resident
of Albuquerque, New Mexico. She has long personal and professional
interest in various aspects of Spanish-American culture. Her historical
interests are complemented by active involvement in current civic affairs
including work with the handicapped, rehabilitation of prison inmates and
many others. In 1974, she was elected to the Board of Regents of the
University of Albuquerque. She also serves as State President of the
New Mexico Women Legislators (she herself was elected to two terms
in the state legislature from 1937-1942 and served as Majority Whip).
In October 1975, Mrs. de Kleven was named Honorary Citizen of the
City of Cadiz, Spain and was elected to their Adolfo Castro Cultural
Institute.

Eugene S. Pulliam, 62, a Republican from the Fifth Congressional District of Indiana represented by Congressman Hillis. (Resume, Tab H) Pulliam is publisher of the Indianapolis Star and the Indianapolis News. Pulliam, whose father also was publisher of the same newspapers, is a capable and respected member of the journalism fraternity. He is active in Indianapolis civic affairs and is well regarded by the leaders in the state. Pulliam is past president of the American Newspaper Publishers Association Foundation, on the Advisory Board of the American Press Institute and a member of the American Society of Newspaper Editors. He is a member of the Indiana Academy of Associated Colleges of Indiana and a Director of the Indiana Historical Society.

Dr. Joe Bob Rushing, 54, a Democrat from the Twelfth Congressional District of Texas represented by Congressman Wright. (Resume, Tab I) Rushing is Chancellor of the Tarrant County Junior College District (Fort Worth, Texas) and is regarded as one of the top junior college administrators in the country. Under his direction the Tarrant County Junior Colleges have developed nationally respected humanities programs. Rushing is a former director of the American Association of Community and Junior Colleges and maintains close ties with the growing number of junior colleges and administrators throughout the nation. He has served as a panelist reviewing fellowship applications in the past for the NEH and would bring a substantial knowledge of the junior college community as a member of the council.

Durward Belmont Varner, 61, an Independent from the First Congressional District of Nebraska represented by Congressman Thone. (Resume, Tab J) Varner is President of the University of Nebraska. He is a former assistant to the President of the Federal Land Bank in Houston and was Assistant Dean of Students at Texas A and M University. He was Chancellor of Oakland University from 1959-1970.

George Will, 34, from the District of Columbia. (Resume, Tab K) Will is a well known and highly regarded syndicated conservative columnist. He was formerly with the political science departments of Michigan State University and the University of Toronto. He was assistant to the chairman of the Republican Policy Committee in 1970.
