Dear Mr. President:

The name of Sarah Goddard Power, a Regent of the University of Michigan, has been proposed for your appointment to the National Commission on the Observance of International Women's Year.

I have known Mrs. Power for many years and consider her excellently qualified for this appointment. Her background includes work as Assistant Chairperson of the Commission for Women at the University of Michigan; Associate Director of the Institute for the Administrative Advancement of Academic Women, in 1973; and Conference Coordinator of Equal Employment Update for Institutional Policymakers, 1974; both held at the University of Michigan.

Mrs. Power's intergovernmental experience includes work as Executive Director of the New York City Commission for the United Nations and for the Consular Corps. Currently, she is Vice Chairperson of the U. S. National Commission for UNESCO and also is Chairperson of the Task Force on the Status of Women. She represented the U. S. National Commission for UNESCO at the International Women's Year Conference in Mexico City in June, 1975.

Mrs. Power is a Director of the United Nations Association and a Director of the Associate Alumnae of Vassar College. She was a roommate at Vassar of one of my nieces, and worked in my New York City office in the early 1960's. Your favorable consideration would be much appreciated.
