BACKGROUND: Mrs. Witherow, a 70 year-old widow, is an uncommitted delegate from the 23rd District in Pennsylvania. She is very conservative but likes Senator Schweiker, and is strongly opposed to Secretary Kissinger. She is particularly upset about current American policy in Africa. Specifically, she opposes United States support of a transition to a black-dominated regime in Rhodesia.

Jack Marsh, Counsellor to the President, has spoken with Mrs. Witherow two times. She is very well-informed and it has not been appropriate for Marsh to answer some of her questions. Drew Lewis has been wrong on Mrs. Witherow and her Congressman, Albert Johnson, has told Mrs. Witherow that he is certain to lose if Ronald Reagan is nominated. She is inclined to listen to Johnson.

TALKING  
POINTS:

- 1) I appreciate the opportunity to talk with you.
- 2) I know that Jack Marsh has talked with you about U.S. policy in Africa, particularly Rhodesia. I hope that you will consider my overall record as President and support me in Kansas City.
- 3) Thank you very much.

BACKGROUND: Secretary Simon has spoken with Mrs. Hans twice during the last week. It is his impression that she will commit if the President calls her. She is very concerned about the President's choice for the Vice President. She would like to see a conservative on the ticket with the President. She could go with someone like Governor Connally or Senator Baker, but not with someone like Vice President Rockefeller or Senator Percy. Her delegate vote seems to depend on the President's choice.

POINTS OF DISCUSSION: As we prepare to go to Kansas City, we feel confident that we are over the 1130 mark needed for nomination. (1134) However, the way the convention is viewed by the public will have a definite effect on the national and many of the state elections.

I know that you have remained uncommitted throughout the race but as we near convention time, it is imperative that we are unified.

With this in mind, I would appreciate it if you could find it possible to endorse my candidacy.

Regarding my choice for the Vice President, I am soliciting comprehensive information on various candidates, all of whom reflect moderate to conservative political philosophy.

BACKGROUND : Mr. James is a retail clothier of men and boy's wear, 47 years old, married and has one child. He is very active in civic affairs and is a member of United Methodist Church. He is an organizational Republican, with 20 years as a precinct committeeman, was State Party Treasurer for 2 years and 1st District Chairman. He is currently chairman for Congressman Sibelius' re-election campaign. He has given private assurances of Ford support to several people, including Jim Baker. The purpose of the President's call is to solicit a public endorsement. His district is primarily an agricultural district and his concerns are agricultural.

TALKING POINTS :

1. Congratulate Mr. James on representing Kansas and the 1st Congressional District as a delegate to the National Convention.
2. Ask him for a public endorsement. He may raise the question of such a public endorsement hurting Congressman Sibelius' campaign because of his position as Chairman. The President can note that:
  - a) Sibelius has an approval rating in the 80% range
  - b) is in a strong re-election position
  - c) that an early wrapping up by a reasonable public margin will reduce inner party tension prior to convention and allow us to get started earlier in the general election

BACKGROUND : Mr. Hartdegen is the Pinal County GOP Chairman in Arizona. He has been active in the Party for the past few years. He is a candidate for the state legislature and is hopeful about his political career.

Mr. Hartdegen has been a delegate committed to Reagan, but since the Schweiker announcement and due to his dislike for the antics of the Reagan forces in Arizona, he is reconsidering his commitment.

As you know, John Rhodes and Mrs. Peter (Freddy) Hershberger are the only Ford delegates elected in Arizona. Paul Haerle has been working on Hartdegen and other Arizona delegates for us.

TOPICS OF DISCUSSION :

- 1) I understand you're a delegate to the National Convention and a candidate for the state legislature. You are to be commended for your dedication and sacrifice to the Party. I know these endeavors are time-consuming, but without determined individuals such as you, the GOP would be in trouble.
- 2) On the matter of the nomination race, how do you feel about Governor Reagan's choice of Senator Schweiker for his running mate?
- 3) Jim, I want you to know I'm quite confident I will be the Party's nominee. I would very much appreciate your support. Are you in a position to support me? (If not, moving to uncommitted is suggested.)


You should not get involved in the question of whether or not the delegates should vote to break the unit rule; that decision is best left up to the Mississippi PFC.

TALKING POINTS:

- 2.) Smith believes firmly that the President should be making a statement on agriculture. The President might well discuss this with him.
