#### INTRODUCTION AND BACKGROUND OF THE BILL

The committee bill is the product of an extensive period of hearings and studies brought about by two acts of critical importance to Federal housing and urban development efforts: first, the rejection by the House Rules Committee in late 1972 of an omnibus housing bill which would have, in part, continued and expanded highly controversial housing subsidy programs; and second, the suspension of these programs by the President in January 1973. As a result of these actions, Federally subsidized housing efforts over the past 18 months virtually ceased, and debate centered on the future role of the Federal Government in meeting the Nation's housing needs.

Although many members of Congress, public officials, and nearly the entire housing industry condemned the Administration's impoundment of housing subsidy funds prior to the development of viable alternative program approaches, the Congress was unwilling to mandate a resumption of the subsidy programs. With limited exceptions, the moratorium continues in effect, frustrating numerous good faith efforts to provide decent housing for thousands of lower income families.

The suspension of housing subsidy programs was accompanied by sharp cutbacks in Federal community development efforts as well, pending enactment of the Administration's "Better Communities Act." Although the Administration subsequently agreed to substantially higher program levels than proposed in the FY 1974 budget for the urban renewal and model cities programs, hundreds of local

CONFERENCE REPORT

[To accompany S. 3066]

The committee of conference on the disagreeing votes of the two Houses on the amendments of the House to the bill (S. 3066) to consolidate, simplify, and improve laws relative to housing and housing assistance, to provide Federal assistance in support of community development activities, and for other purposes, having met, after full and free conference, have agreed to recommend and do recommend to their respective Houses as follows:

That the Senate recede from its disagreement to the amendment of the House to the text of the bill and agree to the same with an amendment as follows:

In lieu of the matter proposed to be inserted by the House amendment to the text of the bill insert the following:  
*That this Act may be cited as the "Housing and Community Development Act of 1974".*

TITLE I—COMMUNITY DEVELOPMENT

FINDINGS AND PURPOSE

*SEC. 101. (a) The Congress finds and declares that the Nation's cities, towns, and smaller urban communities face critical social, economic, and environmental problems arising in significant measure from—*

*(1) the growth of population in metropolitan and other urban areas, and the concentration of persons of lower income in central cities; and*

*(2) inadequate public and private investment and reinvestment in housing and other physical facilities, and related public and social services, resulting in the growth and persistence of urban slums and blight and the marked deterioration of the quality of the urban environment.*
