This responds to your request for our views on the enrolled bill H.R. 6925, "To authorize the exchange of certain lands between the Pueblo of Acoma and the Forest Service."

We recommend that the President approve the enrolled bill.

Enrolled bill H.R. 6925 provides for an exchange of 1,280 acres of land in the Mount Taylor Division, Cibola National Forest, New Mexico, for an equal amount of land now held in trust by the United States for the Pueblo of Acoma of New Mexico. Section 1 of the bill directs the Secretary of the Interior to transfer the Pueblo lands designated therein to the Secretary of Agriculture for inclusion in the Cibola National Forest for administration. Section 2 provides that an equal amount of lands in the Cibola National Forest are to be held in trust by the Secretary of the Interior for the Pueblo of Acoma subject to a right-of-way for existing Forest Service roads. Section 3 makes any transfer subject to valid claims as long as they are maintained.

The Pueblo of Acoma and representatives of the U.S. Forest Service have, for a number of years, been negotiating for an exchange of lands on Horace Mesa involving the lands described in this bill. At the present time these lands form a checkerboard pattern which precludes efficient management. The proposed land exchange, which is acceptable to the Forest Service, would be of particular advantage to the Pueblo as five checkerboard sections of the Pueblo will be consolidated into one unit, thus providing more efficient land use management. The Pueblo will be able to fence the unit, a task which has not been practicable to date because the present boundary is 20 miles in length. The proposed exchange will reduce the boundary to a length of 12 miles.

There is existing authority for exchange of Pueblo lands in general. Members of the Pueblo of Acoma voted to apply the provisions of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984), to their affairs. Section 4 of that Act authorizes the Secretary of the Interior to exchange Indian lands for lands of equal value. However, that authority applies only to certain types of lands, specifically public domain lands. It does not apply to lands which are appropriated for another purpose, such as National Forest Service lands. Therefore, H.R. 6925 is necessary to effectuate this specific exchange.

The Tribal Council of the Pueblo of Acoma adopted Resolution No. TC-MA-26-71A on March 26, 1971, authorizing and requesting the Superintendent of the Southern Pueblos Agency to take whatever action is required to consummate the land exchange as proposed at the earliest possible time. In view of the wishes of the Pueblosas as expressed in the resolution adopted by the Tribal Council, and the benefits which will inure to the Indians, we recommend that the President approve the enrolled bill.

This is in response to the request of your office for a report on the enrolled enactment H.R. 6925, "To authorize the exchange of certain lands between the Pueblo of Acoma and the Forest Service."

The Department of Agriculture recommends that the President approve the enactment.

The enactment directs that two specified sections of land now held in trust for the Pueblo of Acoma Tribe be exchanged for two specified sections of land which are now a part of the Mount Taylor Division, Cibola National Forest, in New Mexico. Rights-of-way would be retained by the Secretary of Agriculture for Forest Service Development System roads now in place on said lands.

Preliminary negotiations for this exchange were started many years ago between the Acoma Indians and the Forest Service but authority to consummate the exchange was lacking. The lands which would be exchanged are similar in character and of approximately equal value.

The ownership pattern of the Indian trust lands and the National Forest System lands in this area is one of alternating sections. Thus, through the exchange, each ownership will be better consolidated with benefits accruing to both the Indians and the United States.

The proviso in section 2 provides that the rights-of-way for Forest Service Development System roads now in place across said lands would be retained by the Secretary of Agriculture. We interpret this as a reservation of all rights and interests necessary to hold, use, and maintain said rights-of-way. This proviso provides adequate protection for our interest in roads in the area.

We are not aware of any opposition to the exchange. The exchange will facilitate management of the Indian and National Forest System lands in the area, and we recommend that the President approve the enactment.

The ownership pattern of the Indian trust lands and the National Forest System lands in this area is one of alternating sections. Thus, through the exchange, each ownership will be better consolidated with benefits accruing to both the Indians and the United States.

Also through the exchange, the Acoma Tribe will acquire grazing rights on lands on which they now hold a National Forest grazing permit. This will also benefit both the Indians and the United States. Section 2, page 2, lines 6 through 10, provides that the rights-of-way for Forest Service Development System roads now in place across said lands would be retained by the Secretary of Agriculture. We would construe this as a reservation of all rights and interests necessary to hold, use, and maintain said rights-of-way.

The Office of Management and Budget advises that there is no objection to the presentation of this report from the standpoint of the Administration's program.

An Act

To authorize the exchange of certain lands between the Pueblo of Acoma and the Forest Service.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of the Interior shall transfer lands and minerals therein, within section 17, township 11 north, range 8 west, and section 13, township 11 north, range 9 west, New Mexico Principal Meridian, now held in trust for the Pueblo of Acoma Tribe, to the Secretary of Agriculture for administration as a part of the Mount Taylor Division, Cibola National Forest, and subject to the laws, rules, and regulations appli-orable to the National Forest System cable to the National Forest System.

SEC. 2. The lands and minerals therein, within section 20, township 11 north, range 8 west, and section 24, township 11 north, range 9 west, New Mexico Principal Meridian, now a part of the Cibola National Forest, are hereby declared to be held in trust by the Secretary of the Interior for the Pueblo of Acoma Tribe: *Provided*, That rights-of-way sixty-six feet in width, being thirty-three feet on either side of the centerline, for Forest Service Development System roads now in place across said lands, shall be retained by the Secretary of Agriculture. SEC. 3. Any transfer effected by this Act shall be subject to valid

claims as long as they are maintained.
