SUBJECT: Enrolled Bill H.R. 17655
Commemorative Medals

Attached for your consideration is H.R. 17655, sponsored by Representative Sullivan, which extends the authorizations for striking commemorative medals for the San Francisco cable car, Jim Thorpe, and the International Exposition on Environment; and would restrict the use of gold for commemorative medals.

OMB recommends approval and provides additional background information in its enrolled bill report (Tab A).

Max Friedersdorf and Phil Areeda both recommend approval.

Purpose

Extends the authorizations for striking commemorative medals for the San Francisco cable car, Jim Thorpe, and the International Exposition on Environment; and restricts the use of gold for commemorative medals.

Discussion

The enrolled bill would amend three statutes to extend the periods of time for which the Secretary of the Treasury is authorized to strike and deliver commemorative medals:

- The authority under Public Law 93-114 would be extended for two years (from December 31, 1974 until December 31, 1976) to strike and deliver up to 150,000 medals commemorating the one-hundredth anniversary of the cable car in San Francisco. (section 1)



- The authority under Public Law 93-132 would be extended for two years (from December 31, 1974 until December 31, 1976) to strike and deliver up to 100,000 medals commemorating Jim Thorpe. (section 2)
- The authority under Public Law 93-221 would be extended for three months (from December 31, 1974 to March 31, 1975) to strike and deliver up to 750,000 medals commemorating the International Exposition on Environment. (section 3)

The enrolled bill would also prohibit the use of gold in any national medals made for public sale under authority of any law, except commemorative Bicentennial medals authorized to be struck by Public Law 92-228, without prior approval by an act of Congress. Violators would be subject to a maximum fine of \$10,000, imprisonment of one year, or both. (section 4)

In reports to the House Banking and Currency Committee, Treasury expressed no objection to the three extensions of medals-striking authority. There was no opportunity to report or testify on the gold content prohibition, but Treasury favors it.

Sir:

Your office has asked for the views of this Department on the enrolled enactment of H.R. 17556, "To extend for two years the authorizations for the striking of medals in commemoration of the one hundredth anniversary of the cable car in San Francisco and in commemoration of Jim Thorpe, and for other purposes."

The enrolled enactment would (1) extend until December 31, 1976, the authorizations for the striking of medals in commemoration of the one hundredth anniversary of the cable car in San Francisco and in commemoration of Jim Thorpe; (2) extend until March 31, 1975, the authorization for the striking of medals commemorating the International Exposition on Environment at Spokane, Washington; and (3) prohibit, except with respect to medals commemorating the bicentennial of the American Revolution, the use of gold in national medals made for public sale under authority of a law of the United States without the express, prior approval, by law, of the Congress.

The Department would have no objection to a recommendation that the enrolled enactment be approved by the President.

An Act

To extend for two years the authorizations for the striking of medals in commemoration of the one hundredth anniversary of the cable car in San Francisco and in commemoration of Jim Thorpe, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the second sentence of the first section of the Act entitled, "An Act to authorize the striking of medals in commemoration of the one hundredth anniversary of the cable car in San Francisco" (Public Law 93-114), approved October 1, 1973, is amended by striking out "December 31, 1974" and inserting in lieu thereof "December 31, 1976".

SEC. 2. Section 4 of the Act entitled "An Act to provide for the striking of medals in commemoration of Jim Thorpe" (Public Law 93-132), approved October 19, 1973, is amended by striking out "December 31, 1974" and inserting in lieu thereof "December 31, 1976".

SEC. 3. The last sentence of the first section of the Act entitled "An Act to provide for the striking of medals commemorating the International Exposition on Environment at Spokane, Washington, in 1974", approved December 29, 1973 (Public Law 93-221), is amended by striking out "December 31, 1974" and inserting in lieu thereof "March 31, 1975".

SEC. 4. (a) Except with respect to medals in commemoration of the bicentennial of the American Revolution authorized to be struck by Public Law 92-228 (approved February 15, 1972), no national medals made for public sale under authority of any law of the United States shall contain any gold without the express, prior approval, by law, of the Congress of the United States.

(b) Any person who violates this section shall be fined not more than \$10,000 or imprisoned for not more than one year, or both.
